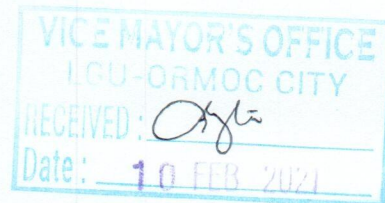

**A RESOLUTION DECLARING AS OPERATIONAL THE
