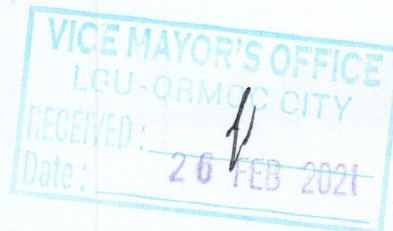

ADOPTED, February 23, 2021.


