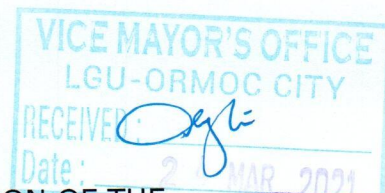
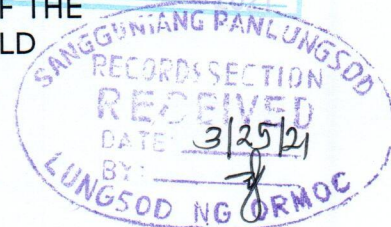

**A RESOLUTION DECLARING THE CLINICAL
LABORATORY WITHIN THE CITY HEALTH
DEPARTMENT COMPOUND AS OWNED BY THE CITY
GOVERNMENT OF ORMOC, AS WELL AS THE
FOLLOWING HEALTH FACILITIES FOR FUTURE
APPLICATION OF LICENCE TO OPERATE, TO WIT: 1.
MEDICAL X-RAY FACILITY; 2. PHARMACY; 3. DENTAL
CLINIC; 4. TB-DOTS CENTER; 5. ANIMAL BITE
TREATMENT CENTER.**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated March 09, 2021 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution declaring the clinical laboratory within the City Health Department compound as owned by the City Government of ormoc, as well as the following health facilities for future application of licence to operate, to wit: 1. Medical X-ray FACILITY; 2. Pharmacy; 3. Dental Clinic; 4. TB-DOTS Center; 5. Animal Bite Treatment Center;

WHEREAS, the City Health Department is already at the final stage in completing the necessary documents for the application of a licence to operate a clinical laboratory;

WHEREAS, Sanggunian, upon review and based on records on file forwarded by the City Legal Office, confirms ownership by the Ormoc City Government of the City Health Department Compound, Medical X-Ray Facility; Pharmacy; Dental Clinic; TB- DOTS Center; Animal Bite Treatment Center;";

WHEREAS, upon consideration, the submission of this Resolution to support an application for a license to operate the subject facilities and equipments is necessary and desirable for the effective operation of the City Health Department and is for the best interests of the city and its constituents;”;


