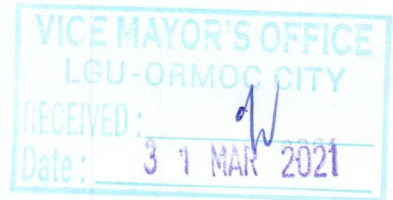

**A RESOLUTION APPROVING AND AUTHORIZING THE  
PURCHASE OF TWO (2) UNITS BRAND NEW SERVICE  
VEHICLE FOR THE OFFICE OF THE CITY TREASURER.**

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated March 16, 2021 respectfully requesting for passage of a Resolution granting authority to purchase Two (2) Units Brand New Service Vehicle amounting to TWO MILLION ONE HUNDRED THOUSAND PHILIPPINE PESOS (PHP2,100,000.00) for the official use of the Office of the City Treasurer;

WHEREAS, the requested vehicle shall be for the efficient execution of business operations of the same office;

WHEREAS, the City Accountant and the City Budget Officer issued Certificates of Availability of Funds dated March 12, 2021 stating therein that the amount of the aforesaid purchase is deemed available and are sourced from the General Fund-Capital Outlay for Motor Vehicles unexpended balance for the year 2016 and 2017, a copy of the certification is hereto attached as Annex "A" and made integral part hereof;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;
