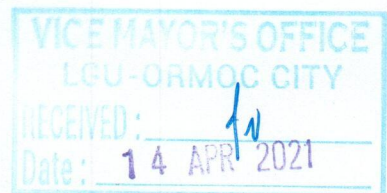


ADOPTED, April 13, 2021.
