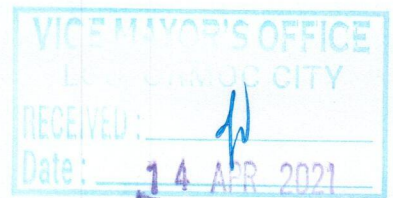

**RESOLUTION NO. 2021-101**

**A RESOLUTION AUTHORIZING THE PAYMENT OF THE  
PRIOR YEAR'S OBLIGATION TO EASTERN VISAYAS  
MAIL IN THE AMOUNT OF ONE HUNDRED FIFTY-  
FIVE THOUSAND SIX HUNDRED FORTY-FIVE  
PHILIPPINE PESOS AND SIXTY CENTAVOS  
(PHP155,645.60) TO BE CHARGED AGAINST THE  
CURRENT YEAR'S APPROPRIATION OF THE CITY  
LEGAL OFFICE UNDER THE OTHER MAINTENANCE  
AND OTHER OPERATING EXPENSES ACCOUNT.**

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated March 26, 2021 from the City Mayor's Office requesting for an issuance of resolution granting the payment of the prior year's obligation to Eastern Visayas Mail in the amount of **One Hundred Fifty-Five Thousand Six Hundred Forty-Five Philippine Pesos and Sixty Centavos (PHP155,645.60)** to be charged against the current year's appropriation of the City Legal Office under the Other Maintenance and Other Operating Expenses Account;

WHEREAS, the Billing Statement from EV Mail for the publication of summon requested by the City Legal Office dated November 17, 2020 and Affidavit of Publication are deemed legitimate, copy of the documents are hereto attached as Annex "A" and "B" respectively, and made integral part hereof;

WHEREAS, the City Legal Officer stated that the publication expense was supposed to be charged against the 2020 Budget however, it was put on hold due to clarifications on the total billing last December leading to delay in submission hence, going over beyond the 2020 budget cut-off;



WHEREAS, the Local Finance Committee issued a Certificate of Availability of Funds dated March 24, 2021 stating therein that the amount requested is deemed available chargeable against the current year appropriation of the aforesaid office under the Other Maintenance and Other Operating Expenses Account, a copy of the certification is hereto attached as Annex "C" and made integral part hereof;

WHEREAS, in order to effect necessary payments of the aforementioned obligations, there is a need for a resolution from the Sangguniang Panlungsod allowing that the same be charged to the Current Year Appropriation of the said office;

WHEREAS, this august Body found the request to be justified and reasonable and is deemed not contrary to existing accounting and auditing laws, rules and regulations;

WHEREFORE, on motion of SP Member Peter M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Tomas R. Serafica, Joan Marbie C. Simbajon and Vincent L. Rama; be it



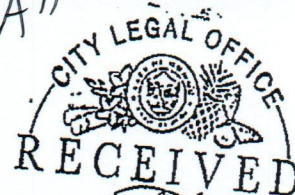

As to who should serve summons, Section 3, paragraph 2, Rule 14 of the Rules of Civil Procedure clearly provides as follows:


In cases where summons is to be served outside the judicial region of the court where the case is pending, the plaintiff shall be authorized to cause the service of summons.

The language used in the provision leaves this Court with no discretion as to who shall be made to serve summons outside of its judicial region. Plaintiff shall, therefore, be authorized in this case to personally serve summons on the defendants above-mentioned.

As regards the rest of defendants whose addresses are unknown or not specifically given, service shall be made through publication once a week for two consecutive weeks in a newspaper of general circulation in the provinces of Leyte and Cebu. Said defendants shall be given 60 calendar days after notice to file their answer.

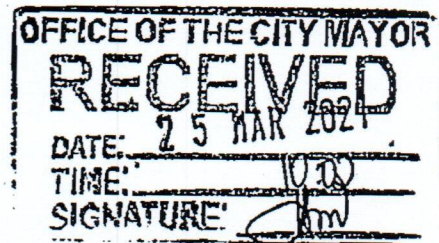
