
A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE PHILIPPINE INSTITUTE OF CERTIFIED PUBLIC ACCOUNTANTS, INC. (PICPA).

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in this City;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty - day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of an application for accreditation of the aforementioned CSO;

WHEREAS, PICPA, duly registered with the Securities and Exchange Commission on 7 March 2006, is an organization of certified public accountants which seek to conduct, undertake and organize seminars, workshops, trainings, conventions and similar activities, to maintain and improve the skills and competence of its members who are rendering services to the general public;



WHEREAS, this Sanggunian, after thorough review of the aforementioned application for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the City Government in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Nolito M. Quilang, Jasper M. Lucero, Vincent L. Rama, Lalaine A. 
