RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN MEMORANDUM OF AGREEMENT (MOA) WITH SAINT ALOYSIUS INSTITUTE OF TECHNOLOGY (SAIT) RELATIVE TO THE HOUSEKEEPING NATIONAL CERTIFICATE (NC) II TRAINING OF THE ORMOC CITY YOUTH DEVELOPMENT OFFICE (OCYDO) NOVEMBER 9, 2020 TO MARCH 3, 2021 UNDER THE PROGRAM OF LITERACY TRAINING FOR OUT-OF-SCHOOL YOUTH.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated April 14, 2021 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or Acting City Mayor the authority to sign the Memorandum of Agreement (MOA) with Saint Aloysius Institute of Technology (SAIT) relative to the Housekeeping Training National Certificate (NC) II of the Ormoc City Youth Development Office (OCYDO) since November 9, 2020 to March 3, 2021 under the Program of Literacy Training for Out-of-School Youth, a copy of the MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, SAIT is a school in Ormoc City that is also TESDA-accredited training institution for vocational and technical courses such as Housekeeping NC

WHEREAS, LGU Ormoc aims to improve the quality of life among out-ofschool youth by empowering them through free technical skills training opportunities, earn national certificate and eventually increase their chances of employability;

WHEREAS, LGU Ormoc and SAIT are in mutual agreement to partner with each other on capacitating out-of-school youth allowing them to learn practical skills through the conduct of Housekeeping NC II training from November 9, 2020 and March 3, 2021 with SAIT conducting the training in their school and with the LGU through the CYDO selecting the participants to the training and paying the costs of the training;

WHEREAS, in an Annotation dated April 12, 2021, the City Legal Office finds nothing legally objectionable in the said MOA and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that the same is entered to equip out-of-school youth with practical skills and training, thereby, serving the best interests of the City and its constituents, and therefore, is most deserving of this august Body's prompt and favorable consideration;

Quilang, Chairman, Committee on Employment, Livelihood, and Manpower Development and Vice-Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Gregorio G. Yrastorza III, Lalaine A. Marcos, Vincent L. Rama and Jasper M. Lucero; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH SAINT ALOYSIUS INSTITUTE OF TECHNOLOGY (SAIT) RELATIVE TO THE HOUSEKEEPING NATIONAL CERTIFICATE (NC) II TRAINING OF THE ORMOC CITY YOUTH DEVELOPMENT OFFICE (OCYDO) SINCE NOVEMBER 9, 2020 TO MARCH 3, 2021 UNDER THE PROGRAM OF LITERACY TRAINING FOR OUT-OF-SCHOOL YOUTH;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This **Memorandum of Agreement** (MOA) is made and entered into this 03 day of November 2020, at Ormoc City, by and between:

The Local Government Unit (LGU) of Ormoc City, a municipal corporation duly existing by and under the laws of the Republic of the Philippines, herein represented by the City Mayor, RICHARD I. GOMEZ, DPA, hereafter referred to as the "LGU"

-and-

The St. Aloysius Institute of Technology, Inc., represented by its School President Richard Redulla, with address at Cinemar Building, Osmeña St., Onnoc City, hereinafter called THE SCHOOL

WITNESSETH

WHEREAS, the LGU aims to improve the quality of life among out-of-schoolyouth (OSY) by empowering them through free technical skills training opportunities, earn national certificate and eventually increasing their chances of employability;

WHEREAS, the LGU has determined housekeeping training as an appropriate venue for capacity building as to positively impact employment of OSYs;

WHEREAS, the SCHOOL is an accredited training provider for Housekeeping Training NCN, by the Technical Education and Skills Development Authority, per , attached hereto as Annex 'A';

WHEREAS, the SCHOOL expressed its intention to execute the Housekeeping Training NCII under the Literacy Training Program to help the Out-of-School Youth to increment the chances of employability to support their financial needs:

WHEREAS, LGU and THE SCHOOL are in mutual agreement to partner with each other on capacitating OSYs by the SCHOOL's conduct of Housekeeping Training NCII under the Literacy Training for Out-of-School Youth allowing them to learn practical skills and prepare them for employment;

WHEREAS, LGU and THE SCHOOL deemed it NECESSARY to FORGE this MOA for a collaborative and coordinative efforts in implementing Housekeeping Training NCII under Literacy Training for Out-of-School Youth.

WHEREAS, The MOA is executed for the implementation of the Housekeeping Training NCII under the Literacy Training of Out-of-School Youth Program in the City of ORMOC, Province of Leyte.

NOW THEREFORE, for and consideration of the foregoing premises the CYDO and SAIT hereto agreed to the following:

Section 1: Objectives

- 1. To facilitate enrolment of out-of-school youth to non-formal education that allows them to learn practical skills and prepare them for employment
- To provide opportunity of out-of-school youth for free training with technical skills and earn national certificate that they can use in applying for a job
- To equip participants with skills in housekeeping services, guest rooms' preparation, laundering and cleaning.

Section 2: Role of Responsibility

1. For the LGU:

- Facilitate the process of registration and written examination of the participants from different Barangays;
- Collect the school requirements of the qualified participants-scholars for the enrollment of the training;
- c. Provide Free Tuition fee and Assessment Fee of 45 Housekeeping Scholars

d. Assist Participants to be employed to partner companies.

2. For the SCHOOL:

- a. Conduct trainings pursuant to TESDA standard for the participant-
- Conduct practical assessment exam to assess the participant-scholars' learning;
- c. Supervise the participants on their On-the-Job Training;
- d. Ensure certification of the participant-scholars who are eligible for certification after completion of all requisite trainings.

Section 3: Amendments

- 1. This MOA does not in any way prevent the parties from entering other stipulations as may hereafter be agreed to by the said parties: and
- No part of portion of this MOA shall be amended or modified without the written approval of the parties hereto.

Section 4: Effectivity and Termination

This Memorandum of Agreement remain in full force and effect from the date of signing hereof, until completion of the training of subject NC II Training subject of this agreement, or until June 30, 2021, whichever comes earlier, unless otherwise terminated or extended by parties concerned. All actions taken by the parties prior to the date hereof in compliance with, and pursuant to, the terms and conditions of this MOA are hereby confirmed and ratified.
