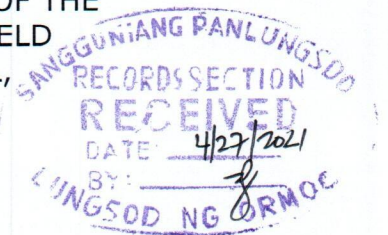

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated April 13, 2021 respectfully requesting for passage of Resolutions granting authority to purchase Two (2) Units Brand New Service Vehicles amounting to Two Million Philippine Pesos (Php2,000,000.00) for the Ormoc TESDC Management Office;

WHEREAS, the requested vehicle shall be used as instructional/training vehicle for TESDA Driving course of the same;

WHEREAS, the City Accountant and the City Budget Officer issued a Certificate of Availability of Funds dated March 25, 2021 stating therein that the amount for the aforesaid purchase is deemed available and is sourced from the CY 2021 General Fund-Motor Vehicles, a copy of the certification is hereto attached as Annex "A" and made integral part hereof;
