A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE DEED OF DONATION (DOD) IN FAVOR OF THE BENEFICIARIES OF DSWD CORE SHELTER RESETTLEMENT SITE IN BARANGAY DANHUG, ORMOC CITY.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated April 26, 2021 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor or Acting City Mayor to enter into and sign the Deed of Donation (DOD) in favor of the Beneficiaries of DSWD Core Shelter Resettlement Site in Barangay Danhug, Ormoc City. Further requesting that this matter be treated as EXTREMELY URGENT, a copy of the DOD standard draft is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Annotation dated April 26, 2021, the City Legal Office finds nothing legally objectionable in the said Deed of Donation and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;

WHEREAS, the City Government of Ormoc is the lawful owner of various parcels of land situated in Brgy. Danhug, Ormoc City;

WHEREAS, the Donees are the qualified beneficiaries, as validated by the Ormoc City Housing Office, of the DSWD Core Shelter Resettlement Site in Brgy. Danhug, established by the City Government of Ormoc as a shelter for the victims of natural calamity during the typhoon "Uring" flashflood on November 5, 1991;

WHEREAS, the Donees accept the parcel of land donated in their favor by the Donor, subject to the terms and conditions contained thereon, and express its gratitude and appreciation for the support, kindness, and liberality of the donor,;

WHEREAS, this Sanggunian, after thorough examination aforementioned Deed of Donation, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign the Deed of Donation, among other lawful purposes, helps improve the beneficiaries standard of living and henceforth, deserving of this august Body's prompt and favorable consideration;

and any transfer or assignment in violation hereof shall be null and void;

- c. The **DONEE** may mortgage the said lot to any financial and/or home-financing institutions, to secure a loan for the construction/repair/remodeling of the house in the said lot, in which case the owner shall notify the City Government of Ormoc;
- d. The conditions in paragraphs (b) and (c) hereof, shall be incorporated in the document of transfer from the City Government of Ormoc to the qualified occupants/beneficiaries, if applicable in the case of (b), and further, annotated in the Certificate of Title that may be issued to the qualified occupants/beneficiaries.

In the event that the conditions of the donation, as contained herein, are not complied with by the **DONEE** and the same is brought to the attention of the **DONOR**, this donation shall be automatically revoked and rendered ineffective and the **DONOR** shall regain ownership over the above-described parcel of land and shall have the right to recover possession of the same. Further, it is understood that the real property taxes due on the property and improvements thereon, as assessed by the City Assessor's Office pursuant to applicable laws, ordinances and rules and regulations, shall be duly paid by the **DONEE**.

That the **DONEE** hereby accept the donation of the described parcel of land and hereby express its gratitude and appreciation for the support, kindness and liberality of the **DONOR**.
