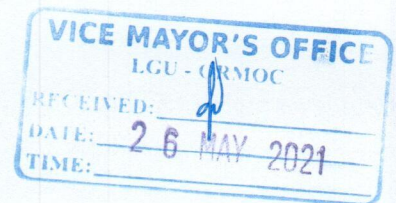


1. BARANGAY NUEVA VISTA
