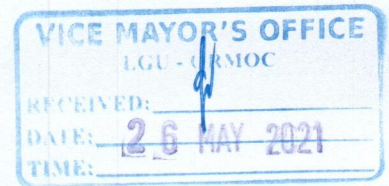
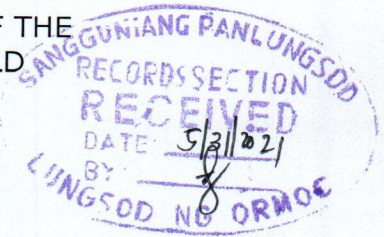

**RESOLUTION NO. 2021-141**

**A RESOLUTION AUTHORIZING THE PAYMENT OF THE  
PRIOR YEAR'S OBLIGATION FOR SERVICES TO  
TRIBOUNDS SURVEYING AND ENGINEERING  
SERVICES IN THE AMOUNT OF TWO HUNDRED  
FORTY THOUSAND PHILIPPINE PESOS  
(PHP240,000.00) TO BE CHARGED AGAINST THE  
CURRENT YEAR'S GENERAL FUND (MOOE) OF THE  
CITY MAYOR'S OFFICE, THIS CITY.**

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Endorsement dated May 6, 2021 from the City Mayor's Office requesting for an issuance of resolution granting the payment for services to Tribounds Surveying and Engineering Services in the amount of Two Hundred Forty Thousand Philippine Pesos (PHP240,000.00) to be charged against the Current Year's General Fund (MOOE);

WHEREAS, in the letter from the City Legal Office to the City Mayor, the service contract is for the parcellary survey of the road-right-of-way going to NHA permanent housing in Brgy. Dolores Ormoc City by the Tribounds Surveying and Engineering Services;

WHEREAS, the aforesaid transaction was not charged to prior year's budget due to delays in the consultancy services contract;

WHEREAS, the Local Finance Committee issued a Certificate of Availability of Funds dated May 4, 2021 stating therein that the amount requested is deemed available chargeable against the current year's General Fund (MOOE), a copy of the certification is hereto attached as Annex "A" and made integral part hereof;



WHEREAS, in order to effect necessary payments of the aforementioned obligations, there is a need for a resolution from the Sangguniang Panlungsod allowing that the same be charged to the Current Year Appropriation of the said office;

WHEREAS, this august Body found the request to be justified and reasonable and is deemed not contrary to existing accounting and auditing laws, rules and regulations;

WHEREFORE, on motion of SP Member Peter M. Rodriguez, Chairman, Committee on Finance and Appropriations, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Vincent L. Rama, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it



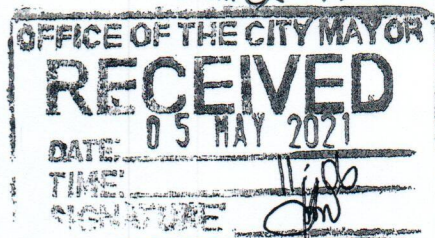

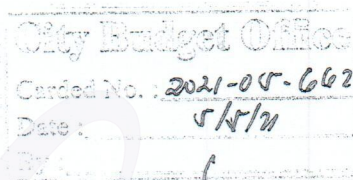
