RESOLUTION NO. 2021-143

A RESOLUTION REVERTING TO THE ORIGINAL PROVISION OF REQUIRING THE PHYSICAL ATTENDANCE OF MEMBERS OF THE SANGGUNIAN DURING THE REGULAR AND SPECIAL SESSIONS AND PRE-SESSION CAUCUS.

WHEREAS, this Sanggunian passed Sangguniang Panlungsod (SP) Resolution No. 2019-001 on June 30, 2019 entitled: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15TH SANGGUNIANG PANLUNGSOD";

WHEREAS, Section 1, Rule VIII of the approved Internal Rules of Procedure of this Sanggunian as amended by Resolution No. 2020-275 dated January 19, 2021 reads as follows:

"Section 1. The regular session of this Sanggunian shall be "once a week" to be held at the Sanggunian Session Hall every Tuesday at exactly 9:00 o'clock in the morning. The session can be conducted through a video conference which shall be attended in the alternative by Teams I and II on each session according to a schedule agreed on by the Sanggunian, to wit:

The City Vice-Mayor or the Presiding Officer and the Majority Floor Leader shall be present during the Session;

The City Vice-Mayor or the Presiding Officer shall appoint a Presiding Officer "Pro Tempore" among the SP Members physically present in the Session Hall, when needed;"

WHEREAS, in view of the fact that the City Government of Ormoc and the People of Ormoc had been able to manage satisfactorily the confirmed cases of Covid-19 in Ormoc City; and additionally, the City Government of Ormoc has come up with the directive requiring physical attendance of all its employees, this Sanggunian deems it proper to revert to the original provision of requiring the physical attendance of the Honorable Members of the Sanggunian while still giving weight to the observance of minimum public health standards to effectively curtail the spread of COVID-19;

WHEREAS, in view of the foregoing, Section 1 Rule VIII shall now read as follows:

"Section 1. The regular session of this Sanggunian shall be "once a week" to be held at the Sanggunian Session Hall every Tuesday at exactly 9:00 o'clock in the morning."

WHEREAS, the PRESIDING OFFICER "PRO TEMPORE", the FIRST ASSISTANT MAJORITY FLOOR LEADER and the SECOND ASSISTANT MAJORITY FLOOR LEADER of Section 1 Rule 5 - OFFICERS shall now be restored from its temporary suspension;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Internal Rules of Procedure and Legislative Tracking, severally seconded by SP Members Tomas R. Serafica, Roiland H. Villasencio, Jasper M. Lucero, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION REVERTING TO THE ORIGINAL PROVISION OF REQUIRING THE PHYSICAL ATTENDANCE OF MEMBERS OF THE SANGGUNIAN DURING THE REGULAR AND SPECIAL SESSIONS AND PRE-SESSION CAUCUS;
