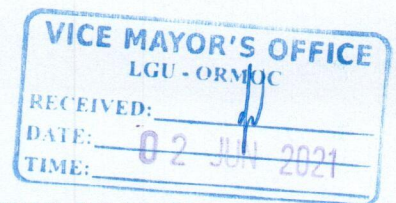
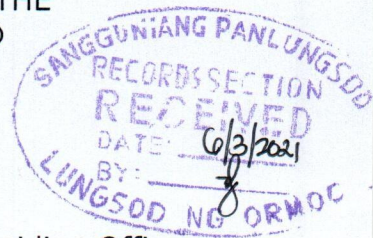


ADOPTED, June 01, 2021.
