ADOPTING AND APPROVING THE A RESOLUTION REDUCTION RISK CITY DISASTER RESOLUTION NO. MANAGEMENT COUNCIL ENTITLED: "A RESOLUTION APPROVING THE TRUST BUDGET PROGRAM AND (LDRRMF) 2021 INVESTMENT PLAN TO INCLUDE DONATIONS-TRUST LIABILITIES DRRMF IN THE TOTAL AMOUNT OF FORTY-SIX MILLION SIX HUNDRED EIGHTY-SEVEN THOUSAND FIVE HUNDRED FIFTY-THREE PHILIPPINE **CENTAVOS** TWENTY-SIX AND PESOS (PHP46,687,553.26)".

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated May 20, 2021 respectfully endorsing three (3) resolutions, to which, one is the Resolution No. 3 which approves the Trust Fund (LDRRMF) 2021 Budget Program and Investment Plan to include Donations-Trust Liabilities DRRMF in the total amount of Forty-Six Million Six Hundred Eighty-Seven Thousand Five Hundred Fifty-Three Philippine Pesos and Twenty-Six Centavos (Php 46,687,553.26);

WHEREAS, during the council meeting, it was found out that there is a balance discrepancy between the Trust Fund record of the CDRRMC and the Office of the City Accountant with the record of the latter higher in amount due to the treatment of Donations in their respective books;

WHEREAS, to reconcile the figure, it was decided that the Donations-Trust Liabilities be added to the Trust Fund (LDRRMF) 2021 Budget Program and Investment Plan;
