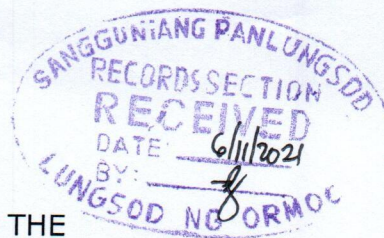


1. BARANGAY DISTRICT I
