A RESOLUTION EXPRESSING THE FULL SUPPORT OF THE SANGGUNIANG PANLUNGSOD TO THE LOCAL SCHOOL 2020-16 BOARD RESOLUTION NO. REQUESTING THE DEPARTMENT OF **EDUCATION** (DEPED) FOR THE CONVERSION OF MONTERICO ELEMENTARY SCHOOL INTO MONTERICO INTEGRATED SCHOOL.

WHEREAS, this august Body was in receipt of Local School Board Resolution No. 2020-16 entitled, "A RESOLUTION ENDORSING TO THE 15TH SANGGUNIANG PANLUNGSOD NG ORMOC THE ESTABLISHMENT OF THE THREE (3) INTEGRATED SCHOOLS IN BRGY. SAN ISIDRO, BRGY. LAO, AND BRGY. MONTERICO, ORMOC CITY";

WHEREAS, in a feasibility study conducted, it was found out that there is a necessity to establish an integrated school in Barangay Monterico considering the distance of the barangay from existing neighboring high schools, namely: Matag-ob National High School and Kananga National High School;

WHEREAS, Monterico Elementary School and its neighboring elementary schools - San Vicente Elementary School, Cacao Elementary School, and L. Cabahug Elementary School - have a combined average number of 126 enrollees in Grade VI which is equivalent to two sections of Grade 7;

WHEREAS, with the establishment of an integrated school in Barangay Monterico, elementary graduates from other neighboring barangays, Barangay Leondoni, Guintiguian, Manlilinao, and Don Potenciano Larrazabal, may now be able to continue their junior high school education with lesser travelling expenses;

WHEREAS, the General Parents and Teachers Association (GPTA) of Monterico Elementary School fully support the conversion and manifested their gratitude to the City Government and their commitment to actively campaign to the parents to enroll their children in Monterico Integrated School;

WHEREAS, the Sangguniang Barangay of Monterico passed Barangay Resolution No. 13, Series of 2020, expressing their full support to the opening of a high school thereby converting their Elementary School into an integrated school;

WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc especially the poor families who find it difficult to send their students to high school due to transportation costs, as this will encourage the young people to continue with their studies so therefore, most deserving of this august Body's full support and affirmative action;

A RESOLUTION ENDORSING TO THE 15TH SANGGUNIANG PANLLINGS OD NG ORMOC THE ESTABLISHMENT OF THREE (3) INTEGRATED SCHOOLS IN BRGY. SAN ISIDRO, BRGY. LAO, AND BRGY. MONTERICO, ORMOC CITY;

WHEREAS, during the Local School Board meeting dated September 14, 2020, SDS Lani Cervantes sponsored the presentation of the proposal to establish integrated schools in Brgy. San Isidro, Brgy. Lao and Brgy. Monterico, Ormoc City;

WHEREAS, the proposal to establish an integrated school will expand these existing public elementary schools to offer complete elementary and junior high school education;

WHEREAS, learner's enrollment in San Isidro Central Elementary School has increased since its installation as the central school in District 10 last July 2018 and the proposal for its establishment as an integrated school will result in savings for the government as facilities of this existing elementary school may be utilized for use of incoming high school students in the neighboring barangays including Bagong Buhay, Doña Feliza Mejia, Libertad and Tambulilid with only repairs and a few additional classrooms to be constructed and will also contribute in the goal of decongesting the existing national high schools particularly New Ormoc City National High School;

WHEREAS, according to the Brgy. Resolution No. 32 s. 2020 of Barangay Lao, Ormoc City, their barangay has two elementary schools namely Lao Elementary School and Jica-Lao Elementary School and graduates from these schools have to travel twelve (12) kilometers daily in going to distant existing secondary schools, hence the need to establish an integrated school in the area to ease the financial burden experienced by the learners and will also be accessible to neighboring barangays such as Liloan, Libertad, Naungan and San Juan, Ormoc City;

WHEREAS, according to the feasibility study conducted by the principal of Monterico Elementary School, the need to establish an integrated school in Brgy. Monterico, Ormoc City is justified by their distance from existing high schools and this is an initiative to allow elementary graduates from the said school and its neighboring barangays including Leondoni, Guintigui-an, Manlilinao and Don Potenciano Larrazabal to continue their junior high school education at a lower cost, especially on travel expenditure;

WHEREAS, the Local School Board expressed their full support in the establishment of integrated schools in the abovementioned barangays since it is consonant with the aim of the city government of Ormoc to bring the educational system closer to the people and encourage the students in communities to pursue their studies;

WHEREAS, City Budget Officer Sabrina Duero advised the DepEd Ormoc City Division Office to have it included in the SEF Budget Preparation for 2021 so funds will be allocated for the construction of school building for the said integrated schools;

NOW, THEREFORE, upon the motion of Ms. Delia Vilbar duly seconded by SP Member Joan Marbie Simbajon, Ms. Maylyn Villamor and Mr. Reynaldo Codog, with no objection from the members, and approved by the presiding officer, be it:

CERVANTES, CESO VI TO CONVERT MONTERICO ELEMENTARY SCHOOL INTO AN INTEGRATED SCHOOL THRU EXPANSION TO BE NAMED AS MONTERICO INTEGRATED SCHOOL SUBJECT TO ALL EXISTING LAWS, RULES, AND REGULATIONS.

WNEREAS, Barangay Monterico, Ormoc City only has an elementary school (Monterico Elementary School) within its jurisdiction with an average of 83% graduates every year;

WHENEAS, the nearest area that offers secondary education to these graduates is Kananga National High School, which is six (6) kilometers away from the Barangay and requires students to take public transportation daily in order to attend class;

WHEREAS, parents of high school students in Barangay Monterico are not able to sustain the financial burden of the daily transportation resulting to 25% out-of-school youths in the Barangay;

WHEREAS, aside from the financial burden imposed, the daily travel from Barangay Monterico to Kananga National High School endangers the students as there are portions of the road network that are accident-prone especially during rainy days;

WHEREAS, students of nearby barangay/s Barangay Cacao, Kananga Leyte, Barangay San Vecinte, Matag-ob Leyte and Don Potenciano Larrazabal Ormoc City will benefit of the planned conversion to an integrated school for the same reasons mentioned above;

WHEREAS, Monterico Elementary School has seven (7) available classroom/s and still has wide space available for building new classrooms for the possible opening of high school classes through school expansion;

NOW, THEREFORE, upon motion of LEA V. ALOGBATE, Chairman of the Committee of Education and duly seconded by all members present, be it:

RESOLVED, as it is hereby resolved, to REQUEST THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY, THROUGH MAYOR RICHARD I. GOMEZ, TO PASS A RESOLUTION REQUESTING THE SCHOOLS DIVISION SUPERINTENDENT OF THE DEPARTMENT OF EDUCATION - ORMOC CITY DIVISION TO CONVERT MONTERICO ELEMENTARY SCHOOL INTO AN INTEGRATED SCHOOL THRU EXPANSION TO BE NAMED AS MONTERICO INTEGRATED SCHOOL SUBJECT TO ALL EXISTING LAWS, RULES, AND REGULATIONS.
