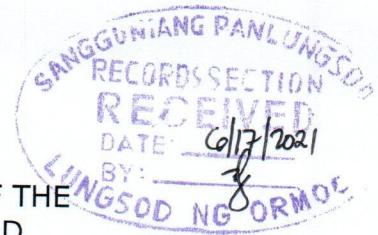

WHEREAS, the Local Finance Committee, this city, has submitted to this august Body for review action the Sangguniang Kabataan Annual Budgets for CY 2021 of the aforementioned Barangays, this city;


1. BARANGAY CAGBUHANGIN


