RESOLUTION NO. 2021-183

A RESOLUTION CALLING **FOR** THE **IMMEDIATE** RESTORATION OF ALL AREAS SUBJECTED EXCAVATION BY THE PHILIPPINES FIBER OPTICS CABLE NETWORKS, LTD. INC. AND ASKING MAYOR RICHARD I. GOMEZ TO MAKE NECESSARY REPRESENTATION(S) WITH PROPER OFFICE(S) AND/ OR AGENCY(JES) ON THE PROPER IMPLEMENTATION OF THE NATIONWIDE FIBER OPTIC CABLE NETWORK PROJECT.

WHEREAS, Section 20, Article II, 1987 Philippine Constitution, states that "the State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments";

WHEREAS, Section 24, Article II, 1987 Philippine Constitution, states that, "The State recognizes the vital role of communication and information in nation-building";

WHEREAS, the Department of Interior and Local Government (DILG) has issued Memorandum Circular No. 2020- 093 directing that LGUs to give full support and assistance to the PFCON in accordance with the provisions of the Ease of Doing Business Act and to facilitate the improvement on information and communication technology services;

WHEREAS, the spirit of the aforequoted constitutional provisions admit of exceptions, such that while this government promotes the recognition of the right of every citizen to own, establish, and operate economic enterprises, especially as it pertains to connectivity, the State is duty bound to exercise its police power pursuant to the General Welfare Clause in the Local Government Code and will yield such power "as may be necessary, appropriate, or incidental for their efficient and effective governance and those which are essential in promoting the general welfare";

WHEREAS, this body is in receipt of several accidents occurring within Ormoc city, due to the unfinished works undertaken by the PHILIPPINES FIBER OPTICS CABLE NETWORKS, LTD. INC. (PFOCN);

WHEREAS, the PFOCN appears to conduct very irregular operations which congest traffic, compromise the safety of the riding and walking public and present threats to the safety of Ormocanons;

WHEREAS, as relayed to this body, the following circumstances attended the continued presence of the PFCON in Ormoc:

- a. In a letter dated May 3, 2021, Engr. Ranulfo D. Oliveros, City Engineer, LGU- Ormoc City, advised Philippine Fiber Optic Cable Network to immediately stop all their underground excavations and instructed to proceed with restoration of all damage structures in the course of their excavations. The letter further states that they are given until May 6, 2021 to complete their restoration activity;
- b. City Mayor Richard I. Gomez, City Engineer Ranulfo Oliveros, Building Official Sonia B. Antonio, and representatives of the 4th Leyte Engineering District have met with PFCON agents on June 2, 2021 and June 4, 2021, to discuss the issues and concerns of their UNDERGROUND EXCAVATIONS, vis-a-vis, RESTORATION of DAMAGE STRUCTURES, during which it was agreed that; 1. PFOCN shall present valid Identifications Cards for all employees including Working Visa or permits for foreigners, 2. To submit SEC REGISTRATION CERTIFICATE, PERMITS and LICENSES from DPWH, OBO or from City Engineering (LICENSE TO EXCAVATE), 3. To stop all excavations and directed to proceed with the restoration of Damage Structures, and lastly, to install safety warning devices like sprinter;
- c. PFOCN has not presented a competent and able representative, knowledgeable on both technical and administrative concerns, and who can proficiently communicate with LGU Ormoc officials;

WHEREAS; in a recent photo taken by the Liga President, Engr. Esteban V. Laurente, with the help of Traffic Enforcement A Management OIC, Mr. Barnsby D. Cagang, it appears that PFOCN continued to do excavation operations without regard for public safety and security;

WHEREAS, this Sanggunian, deems it proper and necessary, to submit a Resolution CALLING FOR THE IMMEDIATE RESTORATION OF ALL AREAS SUBJECTED TO EXCAVATION BY THE PHILIPPINES FIBER OPTICS CABLE NETWORKS, LTD. INC. AND ASKING MAYOR RICHARD I. GOMEZ TO MAKE NECESSARY REPRESENTATION(S) WITH PROPER OFFICE(S) AND/ OR AGENCY(IES) ON THE PROPER IMPLEMENTATION OF THE NATIONWIDE FIBER OPTIC CABLE NETWORK PROJECT;
