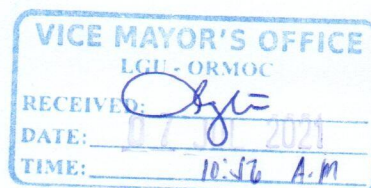

**A RESOLUTION GRANTING AUTHORITY TO THE CITY
MAYOR RICHARD I. GOMEZ OR THE ACTING CITY
MAYOR TO ENTER INTO AND SIGN THE DEED OF
DONATION WITH MR. YOUNGYONG AHN HEREIN
REFERRED TO AS DONOR OF ONE (1) UNIT OF
FIRETRUCK SPECIAL PURPOSE VEHICLE (SPV) AND
ONE (1) UNIT OF MEDICALLY-EQUIPPED
AMBULANCE.**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated June 23, 2021 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor or Acting City Mayor to enter into and sign the Deed of Donation (DOD) with Mr. Youngyong Ahn herein referred to as donor of one (1) unit of firetruck Special Purpose Vehicle (SPV) and one (1) unit of medically-equipped ambulance. Further requesting that this matter be treated as URGENT, a copy of the DOD is hereto attached as Annex "A";

WHEREAS, Mr. Youngyong Ahn, the donor, is a representative and the president of En Plus Co., LTD., that manufactures firefighting vehicles and ambulances;

WHEREAS, the City Government of Ormoc, the donee, pursuant to Sections 22 and 23 of RA No. 7160, otherwise known as the Local Government Code of 1991 (LGC), has the power to acquire and convey real or personal property including negotiating or securing financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 of LGC, from local and foreign assistance agencies, upon authority of the Sangguniang Panlungsod;

WHEREAS, the City of Government of Ormoc is in need of additional fire truck and ambulance;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned Deed of Donation, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation, among other lawful purposes, improves the firefighting capability and emergency response of the City hence, deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on joint motion of SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Public Safety and Disaster Management and SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Gregorio G. Yrastorza, III, Esteban V. Laurente, Lalaine A. Marcos and Jasper M. Lucero; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE DEED OF DONATION WITH MR. 

WHEREAS, the DONOR will arrange the transport and include shipment of the above-mentioned equipment at Philippines Port of Manila or at such other Philippine ports designated by the DONEE.

WHEREAS, This donation is made subject to the following terms and condition:

1. The DONEE undertakes to shoulder all expenses and other related charges for the transfer/registration thereof, if necessary;
2. The DONEE further undertakes to shoulder the expenses for the regular general maintenance and repair of the donated vehicle as may be necessary from the date of receipt and onwards;
3. The DONEE shall shoulder the Donor's Tax, customs duties, tariffs, other revenue taxes and all other applicable/related taxes, costs and related expenses in relation to abovementioned Donation, if any; and
4. The DONEE undertakes to process and attend to the release of the donated vehicle from the Port of Manila and all attendant transportation costs and concerns to Ormoc city;

WHEREAS, in view of the foregoing and BY REASON of the GENEROSITY and APPRECIATION of the DONOR for the services provided by the DONEE, the latter HEREBY voluntarily GIVES, TRANSFERS and CONVEYS by way of DONATION UNTO THE latter, its representatives, assigns and successors in interest, the above- described Fire Pump Vehicle or Special Purpose Vehicle (SPV) and Medically Equipped Ambulance together with all the accessories found thereon free from all liens and encumbrances and with full warranty of title and possession under the law;

The DONEE hereby receives and accepts the abovementioned donation made by the DONOR and further express its gratefulness for the kindness and generosity of the DONOR;
