A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER AND INTO SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF WORKS AND HIGHWAYS (DPWH), OFFICE REGIONAL VIII, RELATIVE TO CONSTRUCTION OF AN EVACUATION CENTER IN BARANGAY DOLORES, ORMOC CITY.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated June 25, 2021 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or Acting City Mayor the authority to sign the Memorandum of Agreement (MOA) with the Department of Public Works and Highways (DPWH), Regional Office VIII, relative to the construction of an evacuation center in Brgy. Dolores, Ormoc City, a copy of the MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Opinion dated June 22, 2021, the City Legal Office finds nothing legally objectionable in the said MOA and that the same is not contrary to law, morals, public order, or public policy, much less detrimental to the best interests of Ormoc City;

WHEREAS, the Government recognizes the fact that it must strengthen the capacities of Local Government Units (LGUs) and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

WHEREAS, to ensure that the evacuation centers shall withstand adverse weather conditions, the DPWH shall formulate appropriate specifications and ensure compliance with the specifications during construction;



WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that the same is entered for the purpose of improving disaster preparedness by constructing an evacuation center, thereby, serving the best interests of the City and its constituents, and therefore, is most deserving of this august Body's prompt and favorable consideration;

MEMORANDUM OF AGREEMENT

LOCAL GOVERNMENT UNIT OF ORMOC CITY, 2 government entity with office address at New Ormoc City Hali, Aunubing Street, Ormoc City, represented herein by its Local Chief Executive, RICHARD I. GOMEZ, herein after referred to as the "LGU ORMOC CITY".

WITNESSETH

WHEREAS, on May 27, 2010, Republic Act 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, was passed into law. This Act aimed to strengthen the country's disaster risk reduction and management system;

WHEREAS, the government recognize and strengthen the capacities of Local Covernment Units (LGU) and communities in mitigating and preparing for, responding to and recovering from the impact of disasters;

WHEREAS, the DPWH is mandated by the laws of the Republic of the Philippines to undertake major infrastructure projects, i.e. (a) planning of infrastructure, such as national roads and bridges, flood control, water resources projects and other public works, and (b) the design, construction and maintenance of national roads and bridges and major flood control systems;

WHEREAS, to ensure that the evacuation centers shall withstand adverse weather conditions, the DPWH shall formulate appropriate specifications and ensure compliance with the specifications during construction;

WHEREAS, DPWH is implementing an Evacuation Center Project as stated in under the General Appropriations Act 2021 which will fund the construction of five (5) evacuation centers in all the regions.

NOW THEREFORE, for and in consideration of the foregoing premises and the covenant, terms, stipulations and conditions herein set forth, the Parties have agreed and by these presents do hereby agree as follows:

Article I - Scope

This Memorandum of Agreement covers the implementation, operation, and maintenance of the Evacuation Center Project in Brgy. Dolores, Ormoc City, Philippines.

Article II - Roles and Responsibilities

The following agencies/office shall have the following roles and responsibilities:

a. DPWH ROVIII

- Ensure that the evacuation center shall be constructed in low risk areas, locations or sites based on the harmonized hazard maps. The evacuation center shall not be implemented in no build zone identified by the Mines and Geosciences Bureau of the Department of Environment and Natural Resources;
- Design and build the Evacuation Center to be resilient from flood, earthquake and other extreme weather events;
- Undertake the procurement process of the project in accordance with RA 9184 and its IRR, follow the usual accounting and auditing rules and regulations, and enter into contract and agreement as maybe required for the project;
- Implement the project in accordance with its approved plans and specifications;
- Otilize the Fund solely for the implementation of the Project;
- Facilitate formal turnover of the completed project to the LGU immediately after the completion of the project.

b. LGU Ormos City

- Provide an area with minimum lot size of 3,000 sq.m. which is identified as a government lot or if the same is in the name of a private person; the necessary Deed of Donation has been executed in favor of the government. In all cases, all the LGUs warrant that the project is free from all infirmities regarding ownership.
- Endorse the location through a Sangguniang Bayan Resolution endorsing the site as location for the Construction of Evacuation Center
- Once site inspection/validation has already been conducted, any changes or modification of location submitted will not be entertained henceforth to avert delay or complications that may occur during the project implementation.
- Undertake the proper maintenance of the facilities
- Allocate funds for the operations and maintenance of the facilities and undertake its upkeep and proper maintenance;
- Ensure that all equipment donated for the improvement and conditions during an emergency should be properly stored in safe areas for use in the future event;
- Ensure availability of security personnel to immediately respond to protection threats and abuses;
- Manage the Evacuation Center during emergencies/calamities

Article III - Anti-Graft and Corruption Practices Act

Neither of the parties to this Agreement shall unduly benefit from each other nor gain anything which is disadvantageous to the Government, and in violation of Republic Act No. 3019, as amended, otherwise known as the Anti-Graft and Corrupt Practices Act.

Article IV - Effectivity of the Agreement

This Memorandum of Agreement shall take effect upon approval by the Parties and shall remain in force and effect.

Article V - Amendments

No amendments, modifications or alterations to this Agreement shall be valid or binding on either Party unless expressed in writing and executed with the same formality as this Agreement.
