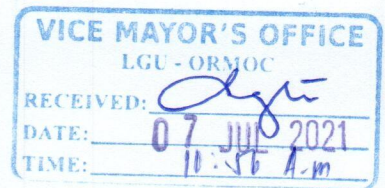

**A RESOLUTION GRANTING AUTHORITY TO THE CITY
MAYOR RICHARD I. GOMEZ TO IDENTIFY AND
IMPLEMENT PROGRAM ITEMS WHICH ARE
APPROPRIATED IN GENERIC TERMS UNDER THE
2022 ANNUAL INVESTMENT PROGRAM (AIP)
PROVIDED, THAT A LIST OF IDENTIFIED AND
PROGRAMMED INFRASTRUCTURE PROJECTS
APPROPRIATED IN GENERIC TERMS FOR A
PARTICULAR MONTH BE SUBMITTED TO THE
SANGGUNIANG PANLUNGSOD ON OR BEFORE THE
15TH DAY OF THE SUCCEEDING MONTH.**

WHEREAS, the 15th Sangguniang Panlungsod of Ormoc City received an Indorsement dated June 21, 2021 from the City Mayor Richard I. Gomez relative to the City Development Council (CDC) Resolution No. 2, Series of 2021, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR RICHARD I. GOMEZ TO IDENTIFY AND IMPLEMENT PROGRAMS ITEMS WHICH ARE APPROPRIATED IN GENERIC TERMS (AIP 2022) PROVIDED THAT A LIST OF IDENTIFIED AND PROGRAMMED INFRASTRUCTURE PROJECTS APPROPRIATED IN GENERIC TERMS FOR A PARTICULAR MONTH BE SUBMITTED TO THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC CITY ON OR BEFORE THE 15TH DAY OF THE SUCCEEDING MONTH AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME;"

WHEREAS, under Executive Order No. 471, Series of 1991, an amendment to Executive Order No. 319, Series of 1987, entitled, "PROVIDING FOR THE REORGANIZATION OF THE LOCAL DEVELOPMENT COUNCILS" in the Philippines, there is a need to further strengthen the local development councils to make them more efficient in accelerating economic and social growth and development at the local level;

WHEREAS, excerpts from the Minutes of the City Development Council (CDC) Meeting of Ormoc City held last June 6, 2021 at the Superdome, Ormoc City, the body has passed and approved the aforesaid resolution primarily to promote effective, efficient and economical governance which will redound to the general welfare of the Ormoc City constituents;

WHEREAS, granting the authority for the City Mayor to identify and implement program items which are appropriated in generic terms (AIP 2022) subject to the condition prescribed thereat, is deemed more practical and convenient process to the city government in order to fast track the implementation of the priority infrastructure projects of the city which are deemed responsive to the present needs and envisioned to propel local economic growth and development;

WHEREAS, the august Body considers the request of the City Development Council as contained in the CDC Resolution No. 2 to be substantial and reasonable. Hence, the matter is most deserving of prompt and favorable consideration;

WHEREFORE, on motion presented by SP Member Esteban V. Laurente, Chairman, Committee on Infrastructure Development, severally seconded by Tomas R. Serafica, Peter M. Rodriguez, Gregorio G. Yrastorza, III, Lalaine A. Marcos, Roiland H. Villasencio and Jasper M. Lucero; be it


