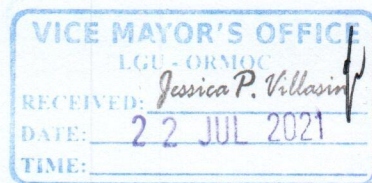


1. BARANGAY DOÑA FELIZA MEJIA


