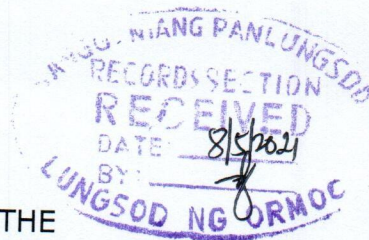

**A RESOLUTION APPROVING AND AUTHORIZING THE
PURCHASE OF ONE (1) UNIT BRAND NEW SERVICE
VEHICLE FOR THE ORMOC CITY PUBLIC MARKET
OFFICE.**

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated July 16, 2021 respectfully requesting for the passage of a resolution granting authority to purchase One (1) Unit Brand New Service Vehicle amounting to One Million Four Hundred Thousand Philippine Pesos (Php1,400,000.00) for the Ormoc City Public Market Office;

WHEREAS, the requested vehicle shall be for the efficient execution of business operations and/or transactions of the aforementioned office;

WHEREAS, the City Accountant and the City Budget Officer issued a Certificate of Availability of Funds dated June 24, 2021 stating therein that the amount for the aforesaid purchase is deemed available and is sourced from the CY 2017 and 2021 General Fund – Motor Vehicles, a copy of the certification is hereto attached as Annex "A" and made integral part hereof;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;



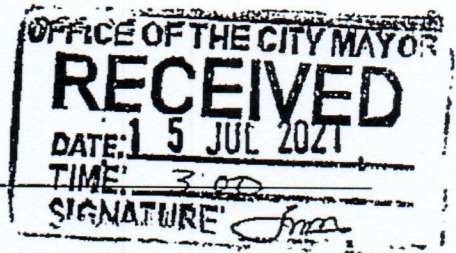
