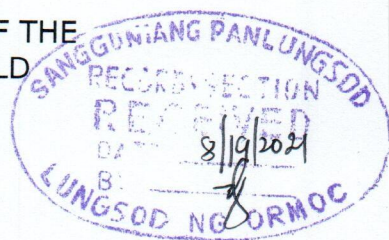

**RESOLUTION NO. 2021-237**

**A RESOLUTION AMENDING SECTION 8, RULE VIII OF  
THE INTERNAL RULES OF PROCEDURE OF THE 15<sup>TH</sup>  
SANGGUNIANG PANLUNGSOD NG ORMOC REGARDING  
THE SCHEDULE OF THE PRE-SESSION CAUCUS.**

WHEREAS, In a Sangguniang Panlungsod (SP) Monthly Management Committee held on August 16, 2021, the SP Members of this august Body have planned to transfer the pre-caucus session in order to properly discuss the agenda of the regular session;

WHEREAS, Section 8, Rule VIII of the approved Internal Rules of Procedure of this Sanggunian reads as follows:

"Section 8. The pre-session caucus of this Sanggunian shall be held immediately after the holding of each regular session. However, additional pre-session caucus may also be held subject to the agreement of the members of this Sanggunian."

WHEREAS, the 15<sup>th</sup> Sangguniang Panlungsod deems it proper to amend Section 8, Rule VIII of the Internal Rules of Procedure to effectively deliberate matters of the agenda in the interest of effective legislation;

WHEREAS, upon deliberation and consideration, this august Body is amenable to transfer the pre-session caucus and still effectively legislate ordinances and issue resolutions without diminishing the plenary powers of this Sanggunian;

WHEREAS, in view of the foregoing, there is a need to amend Section 8, Rule VIII, which shall now read as follows:

**"Section 8. The Pre-Session Caucus of this Sanggunian shall be held at 1:00 o'clock in the afternoon of the same day of the regular session. However, additional Pre-Session Caucus may also be held subject to the agreement of the members of this Sanggunian."**


