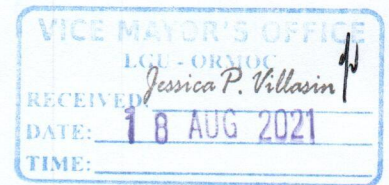
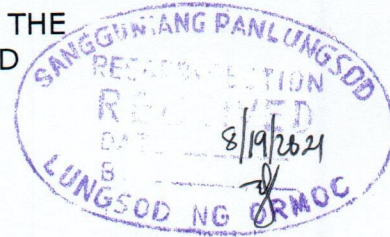

**A RESOLUTION RECOGNIZING THE WIN OF JOHN RIEL
"QUADRO ALAS" CASIMERO AGAINST GUILLERMO "EL
CHACAL" RIGONDEUX IN THE WBO BANTAMWEIGHT
DIVISION CHAMPIONSHIP AT DIGNITY HEALTH
SPORTS PARK, CARSON, CALIFORNIA, UNITED
STATES OF AMERICA HELD ON AUGUST 14, 2021".**

WHEREAS, the City Government of Ormoc has been consistent in giving support to all Ormocanon athletes through its effective sports program in various sports disciplines;

WHEREAS, boxing is one of the highlighted sports in the city by which it produces potential amateur boxers and professional world champions such as the famous boxer named John Riel Casimero;

WHEREAS, John Riel Casimero is an Ormocanon Boxer who has a professional record of 31 wins and 4 losses or 31-4 by which 21 of them are won by knockout;

WHEREAS, on August 14, 2021, he had won over split decision against two-time Olympic Gold Medalist from Cuba, Guillermo "El Chacal" Rigondeux and retained by the former his WBO Bantamweight Belt;

WHEREAS, as per record, Guillermo Rigondeux won against Nonito "Filipino Flash" Donaire in 2013;

WHEREAS, boxing experts believe that it is expected that amateur boxers like Rigondeux have the advantage over Casimero since it was known with the likes of Floyd Mayweather who was an Olympian Boxer turned to a professional boxer applying the skills and styles with a no-loss record;

WHEREAS, Mr. Casimero overcame the odds of the professional experience of his opponent;

WHEREAS, the said event was duly sanctioned by the World Boxing Organization by which some of the greatest Filipino champions had held several title belts;

WHEREAS, the victory of our athlete in the said event has made a historic impact on the world of sports, have been able to overcome the odds of the style of boxer and to prove that it is a matter of hard work and dedication of training is the universal principle of boxing style applicable whether amateur or professional boxing category;

WHEREAS, this august Body finds it appropriate to commend the efforts made by our very own boxing athlete John Riel Casimero who has made our city proud by winning against a former Olympic Gold Medalist in the said event;

NOW THEREFORE, on MASS MOTION of the Body; be it


