RESOLUTION NO. 2021-240

A RESOLUTION GRANTING AUTHORITY TO RUEL G. MARKET ADMINISTRATOR, CANETE, TO ENTER SIGN A COMPROMISE INTO AND AGREEMENT, AMICABLE SETTLEMENT AND THERETO SUBMIT TO ALTERNATIVE DISPUTE RESOLUTION REGARDING THE CASE FILED BY THE OFFICE OF THE CITY PROSECUTOR **AGAINST** THE ACCUSED SEDRICK NULASCO AND ERWIN GUERERO OF THE CRIME OF THEFT OF DILAPIDATED METAL TABLE COMMITTED AT THE ORMOC PUBLIC MARKET LAST MARCH 10, 2021.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated July 29, 2021 regarding a request for the approval of the recommendation of Mr. Vincent L. Emnas, City Administrator, to authorize Ruel G. Cañete, Market Administrator, to enter into and sign the Compromise Agreement, Amicable Settlement, and thereto submit alternative mode of Dispute resolution regarding the case filed by the Office of the City Prosecutor against the accused Sedrick Nulasco and Erwin Guerero;

WHEREAS, the Committee on Good Government finds merit in the request to submit the case to alternative dispute resolution considering that the parties mutually realized and deem it best and convenient to resolve the matter to avoid clogging of dockets in Court;

WHEREAS, the Committee on Good Government supports the assertion of the City Legal Officer that this authority granted to settle the civil aspect of the case taking note of its surrounding circumstances and should not be interpreted to mean that the city adopts condonation as a strategy and it should be emphasized that the City Government will continue to strictly enforce the laws and aggressively apprehend and prosecute criminals and violators;

WHEREAS, the Committee on Good Government, upon motion of SP Member Lalaine A. Marcos, and without any objection approved the request at the Committee level and endorses the matter to the plenary session;

WHEREAS, upon close and thorough discussion, this Sanggunian, finds the grant of authority to Ruel G. Cañete, Market Administrator, to enter into and sign the compromise agreement proper and not contrary to existing laws, morals and public order;

WHEREFORE, on motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government and Oversight, severally seconded by SP Members Roiland H. Villasencio, Joan Marbie C. Simbajon, Vincent L. Rama, Esteban V. Laurente, Gregorio G. Yrastorza III, Tomas R. Serafica and Nolito M. Quilang; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO RUEL G. CAÑETE, MARKET ADMINISTRATOR, TO ENTER INTO AND SIGN A COMPROMISE AGREEMENT, AMICABLE SETTLEMENT AND THERETO SUBMIT TO ALTERNATIVE DISPUTE RESOLUTION REGARDING THE CASE FILED BY THE OFFICE OF THE CITY PROSECUTOR AGAINST THE ACCUSED SEDRICK NULASCO AND ERWIN GUERERO OF THE CRIME OF THEFT OF DILAPIDATED METAL TABLE COMMITTED AT THE ORMOC PUBLIC MARKET LAST MARCH 10, 2021;

COMPROMISE AGREEMENT

This Agreement is entered into by and between:

CITY GOVERNMENT OF ORMOC represented by RUEL G. CANETE, of legal age, Filipino and Officer-In-Charge of Ormoc City Public Market Administrator, hereinafter referred to as the FIRST PARTY and;

SEDRICK NULASCO y Delima and ERWIN GUERERO, of legal ages, both single, Filipinos and residing at Brgy. Ipil and Gaas Ormoc City, Philippines, respectively, hereinafter referred to as the SECOND PARTY.

WITNESSETH THAT:

WHEREAS, FIRST PARTY and SECOND PARTY are the private complainant and accused in Criminal Case No. M-ORM-21-00267-CR for Theft pending before the Municipal Trial Court in Cities, Ormoc City;

WHEREAS, during the pendency of the case, discussions and negotiation of a possible compromise agreement on matters allowed by existing law was made by the SECOND PARTY to the FIRST PARTY;

WHEREAS, after such negotiations and discussions, the parties mutually realized and deem it best and convenient to resolve the matter to avoid filing of the case to court;

NOW THEREFORE, for and in consideration of the mutual covenants and agreements herein established, the parties hereto agreed as follows:

- 1. The SECOND PARTY agrees to pay the FIRST PARTY the total amount of ONE THOUSAND SIX HUNDRED SIXTY (P 1660.00) detailed as P1160 the amount covering the two metal kitchen tables allegedly taken by the accused which are owned by the Ormoc City Government and P500 for the mediation fee to be paid by the SECOND PARTY on the day of the schedule trial of the case:
- 2. That the FIRST PARTY will pursue in filing a criminal case against the respondent if the latter fails to fulfill the obligation stated-above to the FIRST PARTY.

Both parties have executed this agreement by their own and voluntary act and deed and in their mutually agreed terms. Both parties warrant further, that the contents of this agreement were explained to them in local vernacular and signed the same with full understanding of its nature and consequences.
