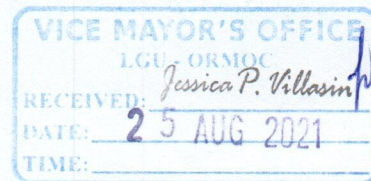
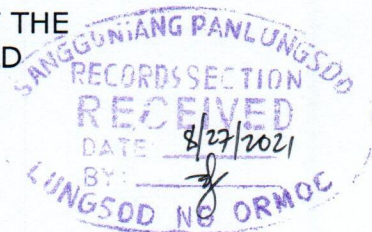

**A RESOLUTION APPROVING AND AUTHORIZING THE
PURCHASE OF TWO (2) UNITS BRAND NEW DUMP TRUCK
OF THE CITY DISASTER RISK REDUCTION AND
MANAGEMENT OFFICE (CDRRMO).**

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated August 2, 2021 respectfully requesting for passage of a resolution granting authority to purchase Two (2) Units Brand New Dump Truck amounting to Eight Million Five Hundred Thousand Philippine Pesos (Php8,500,000.00) to be charged to CY 2021: 70% Trust Fund - LDRRMF;

WHEREAS, the requested vehicle shall be used for post disaster clearing operations as to protect human health, comply with regulations, conserve disposal capacity, reduce injuries, and minimize or prevent environmental impacts;

WHEREAS, the City Accountant and the City Budget Officer issued a Certificate of Availability of Funds dated July 7, 2021 stating therein that the amount for the aforesaid purchase is deemed available and is sourced from the Trust Fund - LDRRMF 70% of the City Disaster and Risk Reduction Management Office, a copy of the certification is hereto attached as Annex "A" and made integral part hereof;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;




