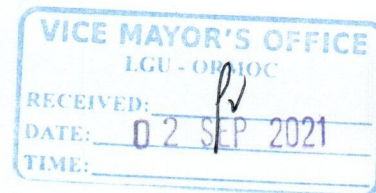

**RESOLUTION NO. 2021-248**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY  
MAYOR RICHARD I. GOMEZ OR THE ACTING CITY  
MAYOR TO ENTER INTO AND SIGN THE DEED OF  
DONATION AND ACCEPTANCE TO BE MADE AND  
EXECUTED BY AND BETWEEN THE PLAN  
INTERNATIONAL, INC. REFERRED TO AS THE  
"DONOR" AND THE LOCAL GOVERNMENT UNIT OF  
ORMOC CITY, REFERRED TO AS "DONEE", RELATIVE  
TO THE REHABILITATION/REPAIR OF THE SOCIAL  
DEVELOPMENT CENTER FOR CHILDREN AND YOUTH  
(SDCCY).**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated August 31, 2021 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor or Acting City Mayor to enter into and sign the Deed of Donation and Acceptance to be made and executed by and between the Plan International, Inc. referred to as the "donor" and the Local Government Unit of Ormoc City, referred to as "donee", relative to the Rehabilitation/Repair of the Social Development Center for Children and Youth (SDCCY). Further requesting that this matter be treated as EXTREMELY URGENT, copy of the DOD and Acceptance is hereto attached as ANNEX "A";

WHEREAS, in an Annotation dated August 31, 2021, the City Legal Office finds nothing legally objectionable in the said Deed of Donation and Acceptance and that the same are not contrary to law, morals, public order, or public policy much less detrimental to the best interests of Ormoc City;



WHEREAS, the donor is a child-centered development organization duly registered under the laws of the Philippines;

WHEREAS, the donee, pursuant to Sections 22 and 23 of RA 7160, otherwise known as the Local Government Code of 1991, has the power to acquire and convey real or personal property including negotiating or securing financial grants or donations in kind, in support of the basic services or facilities enumerated under section 17 thereof, from local and foreign assistance agencies, upon authority of the Sangguniang Panlungsod;

WHEREAS, the donor supports the rehabilitation/repair of the Social Development Center for Children and Youth (SDCCY) that caters to the boys and young men who are categorized as Children At Risk (CAR) and Children in Conflict with the Law (CICL) under existing laws;

WHEREAS, to recall, the parties executed Memorandum of Agreement dated January 26, 2021 for the following objectives: 1. "Rehabilitation/Repair of SDCCY in Ormoc City; 2. The parties understand and commit to join efforts and to maintain a close working relationship to enhance access, quality and use of social service and resources by all children and women needing special protection in order to achieve "Lasting Improvements in the Lives of Children" through "People Empowerment and Promotion of Child Protection Programs";

WHEREAS, the donor has provided for the manpower, material, logistical support for the repair and rehabilitation of the SDCCY, provided equipment for the same;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned Deed of Donation and Acceptance, finds that: the same are not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation and Acceptance, among other lawful purposes, helps in the holistic development and protection of children in conflict with the law and also to those at risk, thus, deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on joint motion of SP Member Lalaine A. Marcos, Chairman, Committee on Women, Family and Gender Development and SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Esteban V. Laurente, Joan Marbie C. Simbajon, Vincent L. Rama and Jasper M. Lucero; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE DEED OF DONATION AND ACCEPTANCE TO BE MADE AND EXECUTED BY AND BETWEEN THE PLAN INTERNATIONAL, INC. REFERRED TO AS THE "DONOR" AND THE LOCAL GOVERNMENT UNIT OF ORMOC CITY, REFERRED TO AS "DONEE", RELATIVE TO THE REHABILITATION/REPAIR OF THE SOCIAL DEVELOPMENT CENTER FOR CHILDREN AND YOUTH (SDCCY);


RESOLVED FURTHER, that a copy of the final notarized Deed of Donation and Acceptance be submitted to this Sanggunian for its information and files;

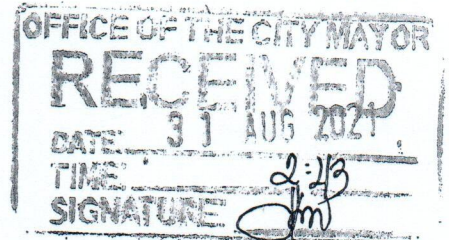
