A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE LAURA VILLE HOMEOWNERS ASSOCIATION, INC...

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in this City;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty – day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of an application for accreditation of the aforementioned CSO;

WHEREAS, Laura Ville Homeowners Association, Inc., duly registered with the Department of Human Settlement and Urban Development the then Housing and Land Use Regulatory Board on 6 June 2001, is an organization whose members were directly affected by the typhoon Yolanda and road-widening projects of the government; they organized themselves to facilitate the delivery of adequate social and economic services with the end view of improving the quality of life of its members;
