

**RESOLUTION NO. 2021-256**

**A RESOLUTION ADOPTING AND APPROVING THE LOCAL  
PUBLIC TRANSPORT ROUTE PLAN (LPTRP) OF ORMOC  
CITY.**

WHEREAS, the Department of Interior and Local Government (DILG) and the Department of Transportation (DOTr), issued Joint Memorandum Circular (JMC) No. 001 (Series of 2017) establishing the "GUIDELINES ON THE PREPARATION AND ISSUANCE OF LOCAL ORDINANCES, ORDERS, RULES AND REGULATIONS CONCERNING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP);

WHEREAS, Executive order No. 125-A and Administrative Order No. 202 series of 1987 and other same national policies, mandate the promotion of the operation of adequate, safe, reliable, efficient and environmental- friendly Public Utility Vehicles (PUVs);

WHEREAS, Section 17 of the Local Government Code (LGC) provides, that "(a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein. xxx";

WHEREAS, public transport is a vital component of a city's transportation system as it serves the majority of the residents especially those from the inner barangays and far flung areas of Ormoc;

WHEREAS, the Local Government of Ormoc City, has identified various important routes all of which will be beneficial to commuters and transport utilities in the city, which has been forwarded to the Land Transportation Franchising and Regulatory Board (LTFRB);

WHEREAS, the LTFRB has approved the 2019-2022 Local Public Transport Route Plan of Ormoc City on June of 2021, a copy of which is attached herewith and made an integral part hereof;

NOW THEREFORE, on MASS MOTION of the Body; be it


