A RESOLUTION FARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE CONSTRUCTION OF A MULTIPURPOSE BUILDING PHASE III PROJECT LOCATED AT COR. MENDOLA AND AUNUBING STREETS, ORMOC CITY IN THE AMOUNT OF TWENTY-FIVE MILLION PHILIPPINE PESOS PHP25,000,000.00) TO BE FUNDED UNDER THE FY GOVERNMENT LOCAL SUPPORT FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF - FA TO LGUS) AND THE SAME IS PART OF THE DULY APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) FOR CY 2021-2023 AND ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2021 OF THE CITY.

WHEREAS, Public Library is an integral part of a learning system as a center for community information service established by the government for public use. As Ormoc City is gearing towards progress and development, improving the quality education of the learners is tantamount to achieving sustainable development. The construction of a multipurpose building located at cor. Mendola and Aunubing Streets is the inception of a new fundamental institution, building in itself a new and well-equipped Ormoc City's public library that can serve all people especially in this computer age. This building is what we need to get access of information from the past and bridge the gap in achieving what we aspire in the future. Our dream is to have a sustainable building for literacy and access to a wide range of reading for all ages;

WHEREAS, an endorsement dated September 16, 2021 was submitted to this august Body requesting for the issuance of a Resolution endorsing the proposed Construction of a Multipurpose Building Phase III in the amount of TWENTY-FIVE MILLION PHILIPPINE PESOS (PHP25,000,000.00) PESOS to be funded under the FY 2021 Local Government Support Fund - Financial Assistance to Local Government Units (LGSF-FA to LGU's) and that the same project is part of the duly approved Local Development Investment Program and Annual Investment Program (FY 2021) of the City Government of Ormoc;

WHEREAS, the requested resolution is pursuant to the requirements set under Item 3.0 of the Local Budget Circular (LBC) No. 131 dated January 3, 2021 with the subject, "Guidelines on the Release and Utilization of the Local Government Support Fund – Financial Assistance to Local Government Units (LGSF-FA to LGUs) in the FY 2021 General Appropriations Act, Republic Act (RA) No. 11518;

WHEREAS, LGSF-FA to LGUs serves as the National Government's response to the various challenges faced by the LGUs in the exercise of their devolved service delivery functions, foremost of which is the raising of sufficient funds for local development. Hence, LGSF was included in the FY 2021 General Appropriations Act to cover, among other, financial assistance to LGUs as support for its priority programs and projects;

WHEREAS, to recall this Sanggunian passed Resolution No. 2020-236 last August 4, 2020 approving the CY 2021 Annual Investment Program (AIP) and Resolution No. 2020-235 approving the Local Development Investment Program (LDIP) for the CY 2021-2023 of the City of Ormoc;

WHEREAS, the construction of a Multipurpose Building Phase III Project is part of the aforementioned approved resolutions after being identified and determined to be consistent with the City's development thrust to provide efficient public service and better quality of life for Ormocanons. Thus, this Sanggunian fully supports the City Mayor's intention of favorably forwarding the said project to be covered under the LGSF-FA program;
