WHEREAS, this august Body was in receipt of Local School Board (LSB) Resolution No. 2021–13, requesting for continued commitment and support of the Local Government of Ormoc in the operations of San Isidro Integrated School, Monterico Integrated School, and Lao Integrated School in the next five (5) years. A copy of the said resolution is hereto attached and made an integral part hereof;

WHEREAS, to recall, the 15<sup>th</sup> Sangguniang Panlungsod ng Ormoc passed Resolution Nos. 160 series of 2021, 161 series of 2021, and 162 series of 2021 expressing full support in the establishment of San Isidro Integrated School, Monterico Integrated School, and Lao Integrated School respectively;

WHEREAS, pursuant to the Department of Education (DepEd) Order No. 40, series of 2014, an action from the Local Government Unit (LGU) must indicate the continued support to provide funds for the operation and maintenance for at least five (5) years or until such time that such funds are incorporated in the national budget;

WHEREAS, pursuant to the Department of Interior and Local Government (DILG) Memorandum Circular No. 2021 – 084, dated August 9, 2021, it urges LGUs to support and be involved in the preparations of the Department of Education (DepEd) for the school year 2021 – 2022. In a statement, DILG Secretary Eduardo M. Año said that "LGUs' involvement in BE 2021 is imperative as quality education remains to be one of national government's priorities despite the hurdles COVID-19 present. He said the schools need all the assistance they can receive, especially that the current pandemic has altered the face of the country's education system from physical classes to virtual." He added that the involvement of LGUs in the Brigada Eskwela 2021 program is a step to ensure that our children continue their education amidst the threat of the pandemic.

WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc as it will ensure delivery of quality education especially among newly-opened high schools and so therefore, most deserving of this august Body's full support and affirmative action;
