RESOLUTION NO. 2021-307

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAXOR RICHARD I. GOMEZ, ON BEHALF OF THE CITY GOVERNMENT OF ORMOC, LEYTE, OR THE ACTING CITY MAYOR, TO FILE AN ACTION WITH THE HONORABLE COURTS RELATIVE TO THE EXPROPRIATION PROCEEDINGS OF LOTS AFFECTED BY THE ROAD CONSTRUCTION AT BRGY. MILAGRO TO BRGY. HIBUNAON AGAINST ALL RELEVANT LAND OWNERS, INCLUDING APPLICATION FOR WRIT OF IMMEDIATE POSSESSION AND SUCH OTHER RELIEFS RELATIVE THERETO.

WHEREAS, this 15th Sangguniang Panlungsod was in receipt of an Endorsement Letter dated 28 October 2021 from the Office of the City Mayor, submitting an urgent request for the issuance of a Resolution authorizing the City Mayor/OIC Mayor/Acting Mayor to cause the filing of a civil action for the expropriation of all lots affected by the road construction at Brgy. Milagro to Brgy. Hibunaon, and application for Immediate Possession, particularly only against all affected lot owners who did not accept the City's offer to buy and other persons acting for and through said affected lot owners;

WHEREAS, the expansion, development and creation of road networks and the public's unhampered access thereto in the City of Ormoc is a vital infrastructure needed for sustained growth and development and for the upliftment of the general welfare;

WHEREAS, as part of the City's Development Plan, there is a need to open a road traversing Brgy. Milagro to Brgy. Hibunaon which would inadvertently traverse the varying properties of the following persons as indicated in the table below;

WHEREAS, the City has already offered to buy the lands affected by the road concreting at Barangay Milagro to Barangay Hibunaon, Ormoc City, and most of the registered owners of the affected lands have accepted the City's offer to buy the affected properties, except for those above-enumerated owners who have refused and continued to refuse the City's offer to buy despite due notice made by the City of its offer to buy;

WHEREAS, the taking and immediate possession of above-described private properties is an imminent and necessary measure that has to be undertaken by the local government unit of Ormoc City, Leyte for public use and a public purpose;

WHEREAS, the Department of Public Works and Highways (DPWH) has already allotted the amount of Twenty Million Philippine Pesos (Php 20,000,000.00) for the Construction of Road at Barangay Milagro to Barangay Hibunaon, which allotment shall be valid for obligation only until December 31, 2021;

WHEREAS, through the exercise of the power of eminent domain, the affected private property may be acquired by the Local Government Unit of Ormoc City through expropriation proceedings and the immediate possession be done upon compliance with the requirements of the law;



WHEREAS, Section 19 of the Local Government Code of 1991 provides:

"Section 19. Eminent Domain. - A local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose or welfare for the benefit of the poor and the landless, upon payment of just compensation, pursuant to the provisions of the Constitution and pertinent laws: Provided, however, That the power of eminent domain may not be exercised unless a valid and definite offer has been previously made to the owner, and such offer was not accepted: Provided, further, That the local government unit may immediately take possession of the property upon the filing of the expropriation proceedings and upon making a deposit with the proper court of at least fifteen percent (15%) of the fair market value of the property based on the current tax declaration of the property to be expropriated: Provided, finally, That, the amount to be paid for the expropriated property shall be determined by the proper court, based on the fair market value at the time of the taking of the property."

WHEREAS, the City Mayor is hereby authorized to perform the following acts, to wit:

- 1. To file in the name of the City of Ormoc any and all necessary pleading and motion expropriation proceedings against the parties of the above-described parcels of land, to include the filing of an appeal and/or special civil actions as may be needed to be interposed in connection with the said case, in connection with which he attests that:
 - a. The allegations in the pleading are true and correct based on personal knowledge, or based on authentic documents, except as otherwise indicated therein;
 - The pleading is not filed to harass, cause unnecessary delay, or needlessly increase the cost of litigation; and
 - The factual allegations therein have evidentiary support or will likewise have evidentiary support after a reasonable opportunity for discovery;
- 2. To represent the City of Ormoc at all stages thereof, including at the pretrial, mediation and judicial dispute resolution, for which purposes hereby authorize the City Mayor to enter into an amicable settlement or submit to other alternative modes of dispute resolution, simplification of issues, and stipulations or admissions of facts and of documents, and to sign in the municipality's behalf the pre-trial order.
- 3. Authority is further given to the City Mayor to do any and all acts whatsoever necessary in order to give full force and effect to this authority, without the power of substitution, and hereby confirming any such acts that he might lawfully do or cause to be done, as the City Government of Ormoc may do or cause to be done if personally present.

WHEREAS, upon close and thorough review of the same, this Sanggunian finds that for purposes of fully protecting the interests of the City, the request on the subject endorsement is deemed to be necessary and meritorious, and further, that the manner chosen upon which the City's interests are to be pursued and protected, is determined to be proper and in order, rendering the request, therefore, deserving of this august Body's prompt and affirmative action;
