A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ACCEPT AND SIGN THE DEED OF DONATION TO BE ENTERED INTO BY THE EASTERN VISAVAS CENTER FOR HEALTH DEVELOPMENT (DOH-EV CHD) IN FAVOR OF THE ORMOC CITY HEALTH DEPARTMENT, FOR THE EQUIPMENT LISTED IN THE DEED OF DONATION, AMOUNTING TO THREE HUNDRED NINETY-SIX THOUSAND EIGHT HUNDRED FIFTY-EIGHT PHILIPPINE PESOS (PHP396,858.00).

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Endorsement dated November 12, 2021 from the Office of the City Mayor, endorsing the herein request for issuance of a Resolution granting the City Mayor or his representative, the authority to sign the attached Deed of Donation to be entered into by the EASTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-EV CHD) in favor to the ORMOC CITY HEALTH DEPARTMENT, for the equipment listed in the Deed of Donation, amounting to Three Hundred Ninety Six Thousand Eight Hundred Fifty Eight Philippine Pesos (Php396,858.00). A copy of the Deed of Donation is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an annotation dated November 10, 2021, the City Legal Office finds nothing legally objectionable in the said DOD and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;

WHEREAS, The State recognizes its mandate to provide and accessible quality healthcare for all Filipinos;

WHEREAS, "Boosting Universal Health Care via FOURmula One for Health Plus (or FI+)" envisions quality health care to be more accessible to the poor and vulnerable population by ensuring the availability of functional health care facilities;

WHEREAS, the Health Facilities Enhancement Program (HFEP) aims to improve the delivery of health services through the upgrading of health facilities and provision of medical equipment in order to make them more responsive to the health needs of the population;

WHEREAS, pursuant to HFEP GAA 2019 with SAA No. 2019-1994 specific facilities were identified to be recipients of various Equipment,

WHEREAS, the provision of various Equipment shall contribute to the functionality of the health system and the delivery of quality health care;

WHEREAS, all health facilities are partners of the DOH-EV CHD in implementing health programs and in delivering quality health services;

WHEREAS, the ORMOC CITY HEALTH DEPARTMENT is one of those identified in the HFEP GAA 2019 as a recipient of Equipment;

WHEREAS, the appropriation for equipment is provided in the General Appropriation Act of 2019 for the Department of Health, under the Health Facilities Enhancement program (HFEP) shall be used for the equipping of Government-owned Health Care Facilities in alignment with Ambisyon Natin 2040 and the Philippine Development Plan 2017-2022;

WHEREAS this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation, among other lawful purposes, facilitates the promotion of health within the City and henceforth, deserving of this august Body's prompt and favorable consideration;

Yrastorza III, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

GOMEZ OR THE ACTING CITY MAYOR TO ACCEPT AND SIGN THE DEED OF DONATION TO BE ENTERED INTO BY THE EASTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-EV CHD) IN FAVOR OF THE ORMOC CITY HEALTH DEPARTMENT, FOR THE EQUIPMENT LISTED IN THE DEED OF DONATION, AMOUNTING TO THREE HUNDRED NINETY-SIX THOUSAND EIGHT HUNDRED FIFTY-EIGHT PHILIPPINE PESOS (PHP396,858.00);

- 1. Conduct actual inventory of equipment needs of its facility following the equipment accreditation/licensing standards for CHO respectively.
- 2. Provide necessary Human Resource, sustained supply of reagents and other supplies/consumables and the sustained budget for the maintenance, repair and Other Operating Expenses of the donated Equipment.
- 3. Ensure that the personnel are trained in the use/operation of the donated Equipment;
- 4. Ensure that the infrastructure/physical facility is ready and expable of housing the donated Equipment;
- 5. Designate a focal person (holding a plantilia position) who shall be authorized to receive in the health facilities:
- 6. Supervise the supplier in the installation of the donated Equipment;
- 7. Ensure that the donated Equipment are properly recorded in the books of assets of the health facility which includes the following essential processes:
 - a. The Property/Supply Officer of the DONEE LGU/Health Facility, shall record the donated Equipment to the Property/Equipment Ledger Card;
 - b. The Accountant of the DONEE LGU/Health Facility, shall record the received equipment in the Journal Entry Voucher (JEV), on the basis of the Property Transfer Report (PTR) and shall give a copy of the Journal Entry Voucher (JEV) to the DOH-EV CHD-HEEP
- 8. Ensure that the donated Equipment will be made operational and used according to their intended purpose:
- 9.Conduct proper inventory accounting of equipment as well as recording of equipment that has been damaged and/or lost due to "FORCE MAJEURE" such as but not limited to fire, earthquake, typhoon, material sabotage, and/or acts of public enemy.

The DONOR affirms that this donation is made in compliance and in accordance with the

ORMOCHYLEAN OFFICE reserves the right to revoke this Deed of Donation in case any of the aforesaid conditions are not faithfully complied with by the DONEE. In case this Deed of Donation is revoked, the DONEE shall surrender the possession of the equipment, including all its accessories, to the DONOR within fifteen (15) working days from receipt of the Notice of Revocation. Ownership of the said equipment shall then vest to the DONOR effective upon receipt by the DONEE of the Notice of Revocation.
