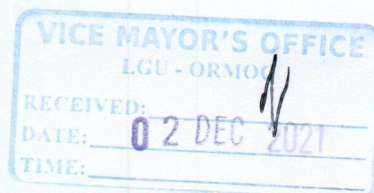

**A RESOLUTION GRANTING AUTHORITY TO THE CITY
MAYOR RICHARD I. GOMEZ OR THE ACTING CITY
MAYOR TO ENTER INTO AND SIGN THE DEED OF
DONATION AND ACCEPTANCE TO BE ENTERED INTO
BY THE PHILIPPINE RICE RESEARCH INSTITUTE
(PHILRICE-BICOL) IN FAVOR OF THE LOCAL
GOVERNMENT UNIT OF ORMOC, FOR 61 BAGS (20KG
EACH) OF RICE SEEDS FOR THE OFFICIAL USE OF THE
CITY SOCIAL WELFARE DEPARTMENT (CSWD).**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated November 17, 2021 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor or Acting City Mayor to enter into and sign the Deed of Donation and Acceptance to be entered into by the Philippine Research Institute (PhilRice-Bicol) in favor of the Local Government Unit of Ormoc, for 61 bags (20kg each) of rice seeds for the official use of the City Social Welfare Department (CSWD), a copy of the DOD is hereto attached as "ANNEX A";

WHEREAS, in an Annotation dated November 16, 2021, the City Legal Office finds nothing legally objectionable in the said Deed of Donation and Acceptance and that the same are not contrary to law, morals, public order, or public policy much less detrimental to the best interests of Ormoc City;

WHEREAS, the DONOR is mandated to implement the development, propagation, and promotion of the inbred rice quality seeds (seeds) under the Rice Competitiveness Enhancement Fund (RCEF), in particular, provide certified inbred seeds to help improve the competitiveness of the Filipino rice farmers, increase their income, and sustain the resilience and responsiveness of the rice industry;

WHEREAS, the DONEE thru its City Social Welfare Department (CSWD) is mandated to address poverty-related concerns, and implement different social welfare and development programs such as relief operations and feeding programs; and is committed to the care, protection, and rehabilitation of individuals, families, groups, and communities;

WHEREAS, the DONOR has undistributed seeds after farmers in certain municipalities opted to plant early or were catered to by the National Rice Program of the Department of Agriculture (DA), and these seeds are no longer suitable as planting materials as shown by appropriate testing procedures;

WHEREAS, the DONEE thru its CSWD is very much willing to receive said undistributed rice seeds and mill the same support of their program;

WHEREAS, in the Waste Material Report issued by Rice Competitiveness Enhancement Fund (RCEF) Seed Program dated April 22, 2021, it stated therein that 61 bags (20kg each) of NSIC Rc222 (CS) are damaged and no longer suitable for planting, free from all liens and encumbrances, a copy of the said report is hereto attached as "ANNEX B" and made an integral part hereof;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned Deed of Donation and Acceptance, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; that the same is entered into for the best interests of the City; and, finally, granting of the authority to sign and accept the Deed of Donation and Acceptance, among other lawful purposes, assists CSWD in addressing and implementing programs that support the needs for nutritional foods and thus, deserving of this august Body's prompt and favourable consideration;

WHEREFORE, on joint motion of SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizen and Persons with Disability and SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE DEED OF DONATION AND ACCEPTANCE TO BE ENTERED INTO BY THE PHILIPPINE RICE RESEARCH INSTITUTE (PHILRICEBICOL) IN FAVOR OF THE LOCAL GOVERNMENT UNIT OF ORMOC, FOR 61 BAGS (20KG EACH) OF RICE SEEDS FOR THE OFFICIAL USE OF THE CITY SOCIAL WELFARE DEPARTMENT (CSWD);




