


RESOLUTION NO. 2021-343

**A RESOLUTION EXPRESSING THE FULL SUPPORT OF
THE CITY GOVERNMENT OF ORMOC ON THE
CONVERSION OF LIBERTY ELEMENTARY SCHOOL
INTO LIBERTY INTEGRATED SCHOOL IN BARANGAY
LIBERTY, ORMOC CITY AND THE COMMITMENT TO
SUPPORT THE OPERATION OF THE SCHOOL IN THE
NEXT FIVE (5) YEARS OR UNTIL SUCH TIME FUNDS
NEEDED ARE INCORPORATED IN THE NATIONAL
BUDGET.**

WHEREAS, this august Body was in receipt of a Local School Board (LSB) Resolution with No. 2021 - 21, entitled: "A RESOLUTION ENDORSING TO THE 15TH SANGGUNIANG PANLUNGSOD THE CONVERSION OF LIBERTY ELEMENTARY SCHOOL TO LIBERTY INTEGRATED SCHOOL AND SECURING THE CONTINUED COMMITMENT AND SUPPORT OF THE LOCAL GOVERNMENT UNIT OF ORMOC FOR THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS. Copy of the said resolution is hereto attached and made an integral part hereof;

WHEREAS, Barangay Liberty is one of the remote barangays in Ormoc City and located 21 kilometers from Barangay Gaas, the closest barangay with high school education and therefore opening a high school in the said barangay is important to accomplish the following objectives: (1) to bring the educational system closer to the residents of the barangay and surrounding communities; (2) to lessen the financial burden of the families in Barangay Liberty and its neighboring communities; and (3) to lessen or eliminate the cases of drop-out among high school students in the said barangay;

WHEREAS, pursuant to the feasibility study conducted by the school principal, it projected an enrollment of 35 learners for Grade 7 on top of the learners currently enrolled in Gaas Integrated School and in Dolores National High School. In addition, Barangay Liberty is accessible to neighboring barangays including Barangays Quezon Jr., Mahayahay, and Barangay Villa Corazon of Burauen, Leyte;

WHEREAS, the Sangguniang Barangay of Liberty passed Barangay Resolution No. 8, 2021, series of 2020, expressing their full support to the opening of a high school thereby converting Liberty Elementary School into an integrated school;

WHEREAS, the General Parent Teachers Association of Barangay Liberty expressed their full support to the establishment of Liberty Integrated School;


WHEREAS, pursuant to Section VI (B.1) of DepEd Order No. 40, s. 2014, the proposed establishment of school must be supported by the local government unit through Sangguniang Panlungsod Resolution supporting the establishment of school into an Integrated School, duly approved by the City Mayor, indicating therein the proposed name of the school; and Certification from the LGU signed by the City Mayor, as the case may be, where the LGU shall continue to provide funds for the operation and maintenance for at least 5 years or until such time that such funds are incorporated in the national budget;

WHEREAS, Section 1 of Executive Order No. 70, issued by the Malacañan Palace on December 4, 2018, entitled: "INSTITUTIONALIZING THE WHOLE - OF - NATION APPROACH IN ATTAINING INCLUSIVE AND SUSTAINABLE PEACE, CREATING A NATIONAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT, AND DIRECTING THE ADOPTION OF A NATIONAL PEACE FRAMEWORK" provides:

"Section 1. Institutionalizing the Whole-of-Nation-Approach. The Whole-of-Nation approach is hereby institutionalized as a government policy for the attainment of inclusive and sustainable peace. Towards this end, the Government shall prioritize and harmonize the delivery of basic services and social development packages in conflict-affected areas and vulnerable communities, facilitate social inclusivity, and ensure active participation of all sector of society in the pursuit of the country's peace agenda"

WHEREAS, in Ormoc City, Project GOMA or Project Governance Outreach in Monitored Areas - a joint Retooled Community Support Program (RSCP) and Capacitating Urban Communities for Peace and Development (CUCPD) strategy on Localizing Executive Order 70 was launched as a social mobilization effort to uplift the lives of the people and advocate good governance in monitored areas/high risk to recruitment and organizing for insurgency. Among of the issues to be resolved under the project is access to education and therefore Project GOMA, in the implementation of the Who-of Nation Approach, aims to ensure the availability and access of Ormocanons to basic services such as Education;

WHEREAS, among the Barangays, Project GOMA identified Barangay Liberty as one of the monitored areas with high risk to recruitment and organizing for insurgency and that the opening of a high school in said Barangay is part of the combined efforts towards coordinated government programs and services and address the issue on access to Education;



WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc as it promotes better access to education among the youth especially among poor families who would likely have difficulties sending their children to school due to distance so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP member Nolito M. Quilang, Chairman, Committee on Education, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III and Esteban V. Laurente; be it





RESOLUTION NO. 2021-21

A RESOLUTION ENDORSING TO THE 15TH SANGGUNIANG PANLUNGSOD THE CONVERSION OF LIBERTY ELEMENTARY SCHOOL TO LIBERTY INTEGRATED SCHOOL AND SECURING THE CONTINUED COMMITMENT AND SUPPORT OF THE LOCAL GOVERNMENT UNIT OF ORMOC FOR THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS;

WHEREAS, during the Local School Board meeting on November 17, 2021, DepEd Ormoc City Division proposed for the conversion of Liberty Elementary School into Liberty Integrated School;

WHEREAS, considering that Barangay Liberty is one of the farthest barangays in Ormoc City, establishing an integrated school in the said barangay is important to accomplish the following objectives: (1) to bring the educational system closer to the people; (2) to lessen the financial burden of the families in Barangay Liberty and its neighboring communities; and (3) to lessen or eliminate the cases of drop-out among high school students in the said barangay;

WHEREAS, as per feasibility study conducted by the school principal, they have projected an enrollment of 35 Grade 7 enrollees and they also have existing constituent learners who are enrolled in Gaas Integrated School and Dolores National High School who may transfer once the request for conversion will be realized;

WHEREAS, the proposed integrated school is also accessible to neighboring barangays including Quezon Jr. and Mahayahay, Ormoc City;

WHEREAS, the Sangguniang Barangay of Liberty, Ormoc City adopted Barangay Resolution No. 8 series of 2021 expressing full support to the establishment of Liberty Integrated School;

WHEREAS, the teaching force and the General Parent Teachers Association of Barangay Liberty also expressed their full support to the establishment of Liberty Integrated School;

WHEREAS, pursuant to DEPED Guidelines for conversion, the proposed conversion of Liberty Elementary School to Liberty Integrated School requires a resolution of support from the Local Government Unit through the Sangguniang Panlungsod expressing that the Local Government Unit of Ormoc shall continue to support the operation and maintenance of the said school in the next five (5) years or until such time that the needed funds for the foregoing are already provided in the national budget as stipulated in the DepEd Order No. 40 series of 2014;


