A RESOLUTION AUTHORIZING THE CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE TO APPROVE THE SUPPORT, AND TO BARANGAY ANTI-DRUG ABUSE COMMITTEE (BADAC) UNDER THE CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 THEREBY ADOPTING CDC RESOLUTION NO. 3, SERIES OF 2021.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Endorsement dated November 29, 2021 from the City Mayor Richard I. WHEREAS, after thorough discussion, the City Development Council (CDC) believes that the identified project and program is vital to the continuous development of the city, necessary, and in accordance to the present needs of the Ormocanon community;
