RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR RICHARD I. GOMEZ TO UTILIZE THE AMOUNT OF ELEVEN MILLION TWO HUNDRED THOUSAND THIRTY-EIGHT PHILIPPINE PESOS AND SIXTY CENTAVOS (PHP 11,240,038.60) TO BE TAKEN FROM THE 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) FUND 2021 (QUICK RESPONSE FUND), AND ALLOCATING SUCH FUND AS CASH ASSISTANCE OF ONE MILLION PHILIPPINE PESOS (PHP1,000,000.00) EACH TO THE FOLLOWING FIVE (5) LOCAL GOVERNMENT UNITS (LGUs) OF SOUTHERN LEYTE COVERED BY THE DECLARATION OF STATE OF CALAMITY, NAMELY:

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated December 24, 2021 from the Office of the City Mayor requesting for the passage of a Resolution authorizing the release of Eleven Million Two Hundred Forty Thousand Thirty-Eight Philippine Pesos And Sixty Centavos (PHP11,240,038.60) each for the above-mentioned severely affected LGUs of Southern Leyte, a copy of the Indorsement is hereto attached as Annex "A" and is made an integral part hereof;

WHEREAS, on December 23, 2021, a Full Council Meeting of the Ormoc City Disaster Risk Reduction and Management was convened and identified five (5) severely affected Municipalities of Southern Leyte, namely: 1. Municipality of Liloan; 2. Municipality of Limasawa; 3. Municipality of Pintuyan; 4. Municipality of San Francisco and; Municipality of San Ricardo;

WHEREAS, to recall, on December 20, 2021, Southern Leyte Governor Damian Mercado declared a State of Calamity due to the tremendous destruction and damage caused by the severe tropical storm "Odette";

WHEREAS, this catastrophe caused thousands of displaced families and massive destruction of properties;

WHEREAS, likewise having gone through a number of similar catastrophes, the people of Ormoc profoundly commiserates with its fellow neighboring Leyteños of the south;

WHEREAS, the City Government of Ormoc was also a recipient of various assistance from generous donors during the time when it was also in dire situation and as a way of paying it forward, manifested its desire to extend financial assistance to these severely affected LGUs;

WHEREAS Section 18 of the Implementing Rules and Regulations of RA No. 10121 otherwise known as "Philippine Disaster Risk Reduction and Management Act of 2010" provides that, "Upon recommendation of the Local Disaster Risk Reduction and Management Office (LDRRMO) and approval of the Sanggunian concerned, the Local Disaster Risk Reduction and Management Council may transfer the said fund to support disaster risk reduction work of other LDRRMCs which are under a State of Calamity"

WHEREAS, Section 5(b) of the Rules and Regulations of RA 8185 or the Local Calamity Fund states that, "A portion of the Calamity Fund may also be authorized to be used by the Local Government Unit concerned to provide financial assistance to other Local Government Units whose area or portion thereof had been declared under State of Calamity by its Sanggunian";

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR RICHARD I. 

A RESOLUTION TO EXTEND FINANCIAL ASSISTANCE OF ONE MILLION PHILIPPINE PESOS EACH TO THE FOLLOWING FIVE LOCAL GOVERNMENT UNITS OF SOUTHERN LEYTE PROVINCE SEVERELY AFFECTED BY TYPHON ODETTE NAMELY; MUNICIPALITY OF LILOAN, MUNICIPALITY OF LIMASAWA, MUNICIPALITY OF PINTUYAN, MUNICIPALITY OF SAN FRANCISCO, AND MUNICIPALITY OF SAN FRANCISCO, AND MUNICIPALITY OF SAN FRANCISCO, AND PESOS, SAID FUNDS TO BE TAKEN FROM THE 5% LOCAL DRRM FUND 2021-QUICK RESPONSE FUND

WHEREAS, the impact of Typhson ODETTE (International Code Name; Rai) which traverses the central Philippine Archipelago from December 16 to December 19, 2021 results to widespread devastation and massive damages to houses, agricultural crops and disruption of critical lifelines and infrastructures and caused the displacement of thousands of residents along the typhoon path;

WHEREAS, Presidential Proclamation No. 1267 of 2021 declares a State of Calamity to Regions IV-B (MIMAROPA), VI (Western Visayas), VII (Central Visayas), VIII (Eastern Visayas), V (Northern Mindanao) and XIII (CARAGA) to hasten the rescue, relief, and rehabilitation efforts of the government and the private sector, including any humanitarian assistance,

WHEREAS, Sec 21 of RA 10121 or the PDRRM Act of 2010 and its Implementing Rules (Rule 18, Section1) states that.... "upon the recommendation of the LDRRMO and approval of the Sanggunian concerned, the LDRRM Council may transfer funds (LDRRMF) to support disaster risk reduction work of other LDRRMCs which are declared under state of calamity" for relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics, or complex emergencies, may be normalized as quickly as possible;

WHEREAS, the City of Ormoc has also been a recipient of various assistance from generous donors during the time when it was also in dire situations and as a way of paying it forward;

PROCLAMATION NO. 1267

DECLARING A STATE OF CALAMITY IN REGIONS IV-B, VI, VII, VIII, X, AND XIII

WHEREAS, last 16 to 19 December 2021, Typhoon Odette (international code name: Rai) caused widespread devastation and damage to houses, infrastructure, properties, and agriculture, and resulted in the disruption of critical lifelines of Filiphos in areas affected by the said typhoon;

WHEREAS, about a million of the population in Regions IV-B (MMAROPA), VI (Western Visayas), VII (Central Visayas), VIII (Eastern Visayas), X (Northern Mindanao), and XIII (CARAGA) were adversely affected by Typhcon Odette;

WHEREAS, pursuant to Republic Act No. 10121, or the "Philippine Disaster Risk Reduction and Management Act of 2010," the National Disaster Risk Reduction and Management Council (NDRRMC) issued Resolution No. 11 (s.2021) recommending the deciaration of a State of Calamity over areas severely and adversely affected by Typhoon Odette;

WHEREAS, the declaration of State of Calamity will hasten the rescue, relief, and rehabilitation extents of the government and the private sector, including any international humanitarian assistance; and

WNEREAS, this declaration will, among others, effectively control the prices of basic goods and commodities in the affected areas, and afford the National Government, as well as local government units (LGUs), ample latitude to utilize appropriate funds for the rescue, recovery, relief, and rehabilitation of, and the continuation of basic services to, affected populations, in accordance with law;

Philippines, by virtue of the powers vested in me by the Constitution and existing laws, do hereby declare a State of Calamity in Regions IV-B, VI, VII, VIII, X, and XIII.

All departments and other concerned government agencies are hereby directed to implement and execute rescue, recovery, relief, and rehabilitation work in accordance with pertinent operational plans and directives.

All departments and other concerned government agencies are also hereby directed to coordinate with, and provide or augment the basic services and facilities of, affected LGUs.



Law enforcement agencies, with the support from the Armed Forces of the Philippines, are hereby directed to undertake all necessary measures to ensure peace and order in affected areas, as may be necessary.

The State of Calamity shall remain in force and effect for one (1) year unless sooner lifted in accordance with law.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
