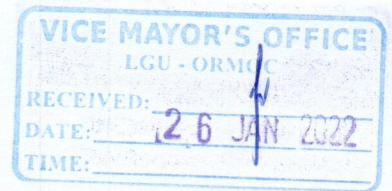

WHEREAS, in a Sangguniang Panlungsod (SP) Resolution No. 2019-016, dated July 30, 2019, it amended and reorganized the composition of the Sanggunian Districts, a copy of the Resolution is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, in order to keep up and respond in an orderly manner with the ever-changing needs of the Sanggunian Districts, it was observed that there is a need to amend and reorganize its composition under their respective chairmanships;
