**RESOLUTION NO. 2022-034**

**A RESOLUTION SUSPENDING THE HEARING OF  
ADMINISTRATIVE CASE NO. 2021-01, ENTITLED:  
MARIA TERESA B. QUEZON, COMPLAINANT, VS.  
MANILYN A. RIZAL, RESPONDENT, ON FEBRUARY 9,  
2022, NINETY DAYS FROM ELECTION DAY.**

WHEREAS, in accordance to Section 62 (c) of Republic Act  
No. 1760 or the Local Government Code of 1991:

"Section 62. Notice of Hearing. - xxx

(c) However, no investigation shall be held within (90) days immediately  
prior to any local election, and no preventive suspension shall be  
imposed within the said period. If preventive suspension has been  
imposed prior to the 90-day period immediately preceding local  
election, it shall be deemed automatically lifted upon the start of  
aforesaid period.";

WHEREAS, based on the foregoing, no administrative investigation shall be  
conducted by the Sangguniang Panlungsod, in the exercise of their jurisdiction to  
take cognizance of administrative complaints against elective local officials within  
their respective disciplinary authorities, within 90 days prior to any election. No  
preventive suspension shall likewise be imposed during the same period if one has  
earlier been imposed, the same shall be automatically lifted at the start of the 90-  
day period;

WHEREAS, given the upcoming local elections this May 9, 2022, all  
administrative hearings shall be suspended starting on February 9, 2022, ninety  
days from said date, which is until Election Day;



WHEREFORE, on motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government and Oversight, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Vincent L. Rama, Esteban V. Laurente and Gregorio G. Yrastorza III; be it


