A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, RICHARD I. GOMEZ, OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGUORMOC) WITH WEST VISAYAS STATE UNIVERSITY FOR THE IMPLEMENTATION OF THE MEDICINE SCHOLARSHIP GRANT AND RETURN SERVICE OR MEDSCHOLAR ORDINANCE

WHEREAS, an indorsement was forwarded to this august Body from the Office of the City Mayor dated February 4, 2022, requesting for an issuance of a Resolution granting authority to the City Mayor or his representative to enter into and sign the Memorandum of Agreement (MOA) with West Visayas State University for Medicine Scholarship Grant;

WHEREAS, Ordinance No. 016 series of 2020 otherwise known as the Medicine Scholarship Grant or MEDSCHOLAR Ordinance aims to ensure adequate supply of doctors in Ormoc City and sustain the effective and efficient delivery of health services. Further, the same ordinance shall strengthen the capacity of the City Government to respond to the challenges especially in meeting the demand for health services;

WHEREAS, Section 11 of the MEDSCHOLAR Ordinance sets the qualifications of a partner school, to wit:

gh.

"SECTION 11. PARTNER SCHOOLS – The Ormoc City Scholarship Board in accrediting partner schools for the Medicine scholarship grant shall give preference to state colleges and universities in the Visayas, unless there is a valid and justifiable reason to consider other schools outside of Visayas region. The following shall be the criteria in accrediting partner schools:

- a. Must be recognized/accredited by the Commission on Higher Education (CHED);
- b. Must have obtained a passing percentage higher than the national board examinations passing percentage for its first-time board examination takers;
- c. Must be able to provide the facilities and infrastructure required in the basic curricula for the study of medicine;
- d. Must have a designated Scholarship Coordinator who shall coordinate with the Ormoc City Scholarship Board on matters pertaining to the medicine scholarship program; and
- e. Willing to execute an agreement with the City Government of Ormoc on the roles and responsibilities of partners in carrying out the scholarship grant."

WHEREAS, in a meeting of the Ormoc City Scholarship Board dated August 6, 2021, the Board deliberated the possible schools for partnership and decided to choose Western Visayas State University as partner school for the MEDSCHOLAR Ordinance highlighting the experience and familiarity of the said university in implementing the DOH Medicine Scholarship Program;

WHEREAS, the Board of Regents of West Visayas State University passed Resolution No. 28 - LL-2022 indicating their interest and willingness to enter into partnership agreement with the City Government in implementing the MEDSCHOLAR Ordinance and confirmed the signing of the abovementioned MOA giving authority to Dr. Joselito F. Villaruz to sign the said MOA, copy of the said resolution is hereto attached and forming part of this resolution;

WHEREAS, it is the policy of the City Government of Ormoc to protect and promote the right to health of the Ormocanons and to strengthen its human resources to meet the needs of its constituents and to ensure that shortage of medical practitioners are addressed;

WHEREAS, as provided for in RA 7160, otherwise known as the Local Government Code of 1991, the City Mayor can enter into contracts and any business transactions for and on behalf of the City Government only upon the authorization of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, upon close and thorough review, this Sanggunian finds that the MOA is not contrary to law, public policy, public morals and existing contracts and finds the stipulations thereon to be in conformity with the relevant ordinances and therefore most deserving of the Sanggunian's prompt and favorable action;

WHEREFORE, on joint motion of SP Member Nolito M. Quilang, Chairman, Committee on Education, and SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Gregorio G. Yrastorza III, Esteban V. Laurente, Peter M. Rodriguez, Eusebio Gerardo S. Penserga, Lalane A. Marcos and Jasper M. Lucero; be it

A. Preliminaries

- The meeting started around 9:28 in the morning at the SP Session Hall.
- Roll call of the Composition of Scholarship Board.
- Atty. Nolito M. Quilang presided the meeting and clarified that for Ms. Farica Z. Cutas she will no longer be representing Mr. Vincent L. Emnas since she is now the head of the HRMO. He further presented the proposed agenda. There was a motion from Ms. Duero severally seconded by Ms. Roa (representing Engr. Cam) and Ms. Simbajon to approve the agenda of the meeting. There being no objection from the Body, the same was approved.
- Presiding Officer requested the Board to review the minutes of the previous meeting dated May 20, 2021 and inquired if there are any comments and/or corrections. There was a motion from Dr. Sombilon (representing Ms. Cervantes) and severally seconded by Ms. Cutas and Ms. Simbajon to approve the minutes of the previous meeting. There being no objection, the same was approved.
- Secretariat reported the following matters arising from the previous meeting.

- Dr. Sombilon clarified on Item G of the matters arising relative to one (1) member per family policy if it is one (1) per year. Atty. Quilang explained that the ordinance is specific that only one (1) member per family can avail and so until the ordinance is amended, no other members of the family can be admitted to the LGU scholarship.
- Ms. Duero informed the Board that the latest number of newly admitted LGU scholars is 169. She also inquired from the secretariat if those four (4) scholars under the discretionary slots of the City Mayor are included in the list. The secretariat responded Yes.
- There were suggestions under Item H relative to the Barangay Scholarship Program, to wit:
 - ✓ Dr. Sombilon suggested to look for a sponsorship from our graduated scholars who are now gainfully employed. This is something the City Government and the barangays can collaborate to mobilize alumni scholars to help and donate funds to send more to college.
 - Ms. Wenceslao also added in support of Dr. Sombilon's suggestion, she shared that EDC for tech-voc they have a give-back program and might as well if we have the data for those graduated scholars with gainful employment and try to contact them to at least give some donations in support for the scholarship program of the City.
 - Ms. Duero suggested that SK can actively participate in the Barangay Scholarship Program since education is included in the priority programs of the SK. One option to consider is cost-sharing between SK and the barangay to be able to send one to college or to acquire Voc-tech skills.
 - ✓ SBM in-charge of education should lobby for scholarship funding from the barangay funds.
- Data for graduated scholars with gainful employment can be done by ESO.
- Atty. Quilang advised the secretariat to assist the SK in drafting their guidelines to help SKs on how to go about allocating funds for scholarship.
- Ms. Duero also explained that it is in the ordinance that the Barangay is mandated to have their own scholarship program. This should already be enough basis for allocation of funds to the scholarship program.
- on Laurente clarified on Item B the status of existing scholars relative to the 11 terminated scholars as to what extent that they are terminated, what year level and are schools already been paid because in SVSF it is hard for them to terminate scholars. Atty. Quilang responded that the reasons for termination can be found in one of the attached documents in the agenda file. The schools will still be paid until the semester ends. The allowances are only withheld until such time the scholars submit their Certificate of Grades (COG) which should be before the next semester begins otherwise, they will be terminated. Atty. Quilang suggested to ESO to also communicate with partner schools those terminated or those no longer included in the LGU scholarship.
- Atty. Quilang also asked about the action of the Board relative to the request of Ms. Rothciel L. Romero for a certification as LGU scholar since Ms. Diaz cannot provide data. Ms. Duero clarified that actually there was no letter request coming from Ms. Romero and it was only through a verbal communication. The Board shall wait for the scholar to write a letter request.

C. HIGHLIGHTS OF THE MEETING

- Status of Scholars
 - a. Actual number of new scholars admitted
 - The secretariat presented the data as of July 27, 2021 it was 171 including the four (4) PWDs under the discretionary slots of the City Mayor but as of August 6, 2021 the actual number is now 169. They just received notice from two (2) more scholars not pursuing the LGU scholarship.
 - b. Number of graduates
 - ✓ Only 18 scholars graduated this SY2020-2021.
 - ✓ ESO is advised to maintain an active database of scholar graduates updated on who are employed and those unemployed. The ESO should monitor regularly the graduates and assist in helping them get a job.
 - c. Number of terminated scholars
 - ✓ 29 scholars were terminated including those 11 mentioned in the report on matters arising.
 - Ms. Roa (representing Engr. Cam) suggested that ESO must do something to help scholars avoid/prevent from getting pregnant during the period of scholarship. Atty. Quilang suggested to include session on Adolescent Reproductive Health during the scholars' assemblies.
 - Dr. Sombilon also brought up the impact in the future with the scholarship recipients dominated by female students. He asked ESO to come up with sex disaggregated data on the scholars per course to see the courses that are male and female dominated.
 - Dr. Laurente shared that they also have a problem with teenage pregnancy but their approach is different because they are in a catholic school. She also announced to the Board that they still have two open slots for scholarship in case any Board Member would like to endorse.
 - Dr Sombilon inquired on the reasons for drop-out of scholars. Ms. Duero explained that those terminated scholars were not only because they have dropped but also include those who waived their LGU scholarship by choosing the Tertiary Education Subsidy (TES) program of the CHED.
 - Dr. Lampong also suggested that bi-monthly meeting may be conducted to give the students venue to express their feelings or problems especially on their academic status. The CHO can assist on mental health since they have the LAMDAG program. Ms. Duero and Ms. Roa agreed and suggested that Psychosocial & Mental Health can be included during scholars' assemblies.
 - Dr. Arradaza also suggested to create a chat group for scholars per school. The chat group should be moderated so that problems and issues can be noted and these can then be presented to the Board.
 - Dr. Lampong also added that a meeting with the teachers would be helpful so that the LGU can also hear the feedback of the teachers. In this regard, the ESO is advised to strengthen the coordination with the scholarship coordinators for each partner school. Dialogues can be organized per school so that interventions can also be done per school. The scholarship coordinator can help mobilize scholars and maybe some teachers for a dialogue.
 - Ms. Hermosilla suggested that after the ranking examination, the scholars must undergo Career Coaching Session in order to minimize dropping and termination. Atty. Quilang responded that ESO can study the possibility of

- ESO is advised to already conduct briefing on those who will secure application form like the preferred courses, choice of schools, ranking and the quota system. This is to avoid complications later on when results are released and problems are encountered.

- Ms. Duero clarified if the rate for assessment is based on TESDA rates. Mr. Nobria responded Yes. Ms. Duero also informed the Board that upon verification by the secretariat, Mr. Larrazabal who is in the list, his wife already availed of the scholarship for TM and based in our policy only 1 member per family. Mr. Nobria responded that they will substitute him and will give the latest copy of beneficiaries. The amount requested will be changed since the allowance per student is 65 pesos based on the quidelines.
- Atty. Quilang suggested that for the next meeting, the secretariat should present data on tech-voc and academic scholars per barangay so that the Board is guided on whether or not to pass a policy on equity among barangays in the access to scholarship opportunities.
- Dr. Sombilan moved and duly seconded by Ms. Duero to approve the request of TESDO in the amount of One Million Sixty-Two Thousand Seven Hundred Eleven Pesos and Seventy-Six Centavos (P 1,062,711.76) for scholarship grants to Seventy-Five (75) students for EIM and SMAW. With no objection, the motion is approved.

Status of Medicine Scholarship Program

- The secretariat presented to the Board the four (4) medical schools who replied via email with their comments/suggestions pertaining to LGU-MOA, to wit:
 - 1. University of Cebu College of Medicine Foundation, Inc.;
 - 2. West Visayas State University (WVSU);
 - 3. Silliman University; and
 - 4. Cebu Institute of Medicine.
- Among the above-mentioned prospect partner schools, only WVSU is a state university. Atty. Quilang first suggested to let the City Health Department recommend as preference. The Board eventually agreed to tie-up with WVSU since the remaining three (3) are all private schools. Atty. Quilang advised the secretariat that once there's already clearance from City Legal then inform the WVSU of the intent of the City Government to pursue the partnership so that the scholarship program can begin to accept applicants.

Atty. Quilang advised the secretariat that next time if there are many request letters for change of course and waivers then it must have a summary list. Also to note that the scholar has to submit their prospectus for the current course enrolled and the course they wanted to shift.
