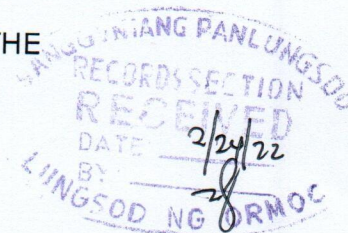

**AN OMNIBUS RESOLUTION APPROVING AND
AUTHORIZING THE PURCHASE OF ONE (1) BRAND-
NEW SERVICE VEHICLE FOR EACH OF THE
FOLLOWING OFFICES, TO WIT:**

- 1. PUBLIC EMPLOYMENT SERVICE OFFICE (PESO);**
- 2. BUSINESS PERMITS AND LICENSING OFFICE (BPLO);**
- 3. ORMOC CITY TOURISM OFFICE (OCTO); AND**
- 4. CITY BUDGET OFFICE (CBO)**

WHEREAS, the Sanggunian was in receipt of an urgent Endorsement Letter from the Office of the City Mayor dated February 18, 2022 respectfully requesting for a passage of a Resolution granting authority to purchase a total of Four (4) brand new service vehicles;

WHEREAS, the requested vehicles shall be for the efficient execution of business operations and/or transactions of the aforementioned offices;

WHEREAS, to recall, this Sanggunian approved Appropriation Ordinance No. 01, Series of 2022 otherwise known as the 2022 Annual Budget of the City of Ormoc enacted on December 14, 2021, approving therein a total budget of Thirty-One Million Six Hundred Thousand Philippine Pesos (Php31,600,000.00) under the General Fund intended for Motor Vehicles purchases;

WHEREAS, the City Accountant and the City Budget Officer issued separate Certificates of Availability of Funds for the motor vehicle Purchase Request of each offices stating therein that the funds for the same are deemed available and are sourced from the CY 2022 General Fund, a copy of the certifications are hereto attached as Annex "A", "B", "C", "D" and made an integral part hereof;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;

4. CITY BUDGET OFFICE (CBO)
