

BARANGAY ORDINANCE No. 003 Series of 2021 Authored by: SBM. FLORDELIZA E. NAVARRETE

AN ORDINANCE STRENGTHENING RESPONSIBILITIES OF PARENTS OR GUARDIANS ON THE RIGHTS OF CHILDREN WITHIN THE SEVENTEEN PUROKS OF BARANGAY LINAO BY PROVIDING INCENTIVES THROUGH THE INSTITUTIONALIZATION OF THE MOSTCHILD-FRIENDLY PUROK AWARDS

#### **EXPLANATORY STATEMENT**

WHEREAS, the Philippines is a signatory in the United Nations Convention on the Rights of the child, the Declaration of the Rights of the Child and the Geneva Declaration of Rights of the Child;

WHEREAS, it is the declared policy of the State set forth in Sec. 13, Article 1 of the Philippine Constitution and of the City of Ormoc to protect and promote the physical, moral, spiritual, intellectual and social being of children;

WHEREAS, children being the greatest possession and the next leader and steward of Barangay Linao should be afforded the necessary protection and support so that they can fully grow, develop and assume its responsibilities within the community;

WHEREAS, this Barangay Ordinance No. 003 seeks to ensure and strengthen the efficacy and responsiveness of parents/guardians towards children's rights and welfare;

WHEREAS, on motion by Hon. SBM. Flordeliza E. Navarrete and duly seconded by all SBM present, be it

**ORDAINED**, by the Council of Barangay Linao, in session assembled that:

SECTION I. TITLE- This Ordinance shall be known as the "Most Child-Friendly Purok Award Ordinance";

**SECTION 2. PURPOSE** – This Ordinance is promulgated in order to:

- a. Protect and promote the rights and welfare of children;
- b. Strengthen the responsibleness and responsiveness of parents/guardians for the children's protection and welfare;
- c. Establish a sustainable mechanism that will continually drive parents/ guardians to support innovative programs of the Barangay for protecting and promoting children's rights and welfare.

SECTION 3. COVERAGE – This Ordinance shall cover all parent/s/guardian and children residing at the seventeen (17) puroks of barangay Linao and shall focus on the effectiveness and innovativeness of the program on the protection and promotion on childrens rights and welfare.

**SECTION 4. THE MOST CHILD-FRIENDLY PUROK AWARD-** The Most Child-Friendly Purok Award is hereby established to be conferred by Awards Committee which have met the criteria and conditions prescribed in this Ordinance.

SECTION 5. CRITERIA - The Most Child-Friendly Purok Award shall be rated in the following criteria:

### I. STANDARDS OF CHILD-FRIENDLY PUROK

A. SURVIVAL ----- 30 pts.

- 1. Child Health
  - a. All children are registered at birth

5 pts

All infants are exclusively breastfed up to 2 years old

2 pts

- c. All children are fully-immunized against Tuberculosis, Diphtheria/Pertussis/Tetanus.
  - Measles and Polio

3 pts

d. All children 0-2 years old are weighed, monthly and quarterly

2 pts

e. All children are nourished well, not underweight nor overweight

3 pts

f. All children are given one dose of Vit. A starting 6-11 mos.; 1-5 years old are given Vit. A capsule twice a year

2pts

- 2. Maternal Health
  - a. All births are attended to by trained personnel

2 pts

b. All pregnant women get at least 4 complete pre-natal check-ups

3 pts

c. All mothers are fully immunized against Tetanus

2 pts

d. All pregnant/lactating mothers are given sufficient Vit A and Iron

- e. All pregnant women who are at risk get Emergency Obstetrical care 2 pts
- f. All pregnancies are spaced at least 2 years apart 2 pts.

# B. DEVELOPMENT -----20 pts.

- All children 3-4 years old attend Early Childhood Care Program
   5 pts.
- All children 6- 17-year-old are completing Basic Education Program through regular or alternative delivery mode
   5 pts
- c. All children promoted to Grade Eleven level attain mastery of functional literacy/life skills level
   10 pts

# C. PROTECTION ----- 30 pts.

- 1. Protection from Risk
  - All illiterate parents/guardians are enrolled in functional literacy program
     5 pts
  - b. All children are removed from exploitative and hazardous labor, prostitution and pornography

5 pts.

c. All cases of physical, psychological and sexual violence are eliminated in the home and purok

5 pts

- d. All children in conflict with law are separated from adult detainees 4 pts
- 2. Promotion of Safe and Livable Home
  - a. All families have safe drinking water

2 pt

b. All families used iodized salt

2 pts

c. All families have sanitary toilet

2 pts

d. All fathers and mothers share in the care and rearing of children
 5 pts.

#### D. PARTICIPATION ----- 20 pts.

a. All children 12-17 years old participate in socio-cultural and community development activities.

10 pts.

 All children 12-17 years old are actively involved in an organized Barangay Children Organization
 10 pts.

## SECTION 6. COMPOSITION OF THE MOST CHILD-FRIENDLY PUROK AWARDS COMMITTEE

- The Most Child-Friendly Purok Awards Committee is hereby duly constituted and shall be composed of the following:

SECTION 7. DUTIES AND FUNCTIONS OF THE COMMITTEE- In order to efficiently and effectively implement the Most Child-Friendly Purok Awards, the committee composed in the preceding section shall:

- 1. Search, validate, review, evaluate and select the Most Child-Friendly Purok Awardees following the established guidelines, rules and criteria of the awards;
- 2. Submit to the Barangay Linao Council headed by the Punong Barangay on or before October 31 of every year the list of the Most Child-Friendly Purok Awardees for approval and conferment in November of every year.

**SECTION 8. THE SECRETARIAT-** The Barangay Children Affairs (BCA) office shall provide the secretariat functions of the Most Child -Friendly Purok Awards Committee.

SECTION 9. FUNCTIONS OF THE SECRETARIAT- The secretariat shall have the following functions and duties:

- 1. Serves as repository of all documents, memorabilia, pictures and other related information on the Most Child-Friendly Purok Awards;
- 2. Provide the Most Child -Friendly Purok Awards Committee with the various forms, guidelines and criteria of the award;
- 3. Assist in the search of the Most Child -Friendly Purok Awardees;
- 4. Plan and conduct a Most Child -Friendly Purok Awards presentation in November of every year during the celebration of the children's Month.

SECTION 10. ASSESSMENT, EVALUATION AND SELECTION PERIOD- The assessment, evaluation and the selection period shall cover from the month of JANUARY until OCTOBER of the current year.

SECTION 11. AWARDING AND PRESENTATION OF THE MOST CHILD-FRIENDLY PUROK AWARDEES – Awarding and presentation of the Most Child-Friendly Purok Awardees shall be in November of every year. The event shall be the highlight of the Barangay Linao Children's Month Celebration.

SECTION 12. THE AWARDS- The recipient of the MOST CHILD-FRIENDLY PUROK AWARDS shall be given the following prizes:

1st place - Ten Thousand Pesos (10,000.00) cash

(with a rating of 95 pts.- 100 pts.)

2<sup>nd</sup> place – Eight Thousand Pesos (8,000.00) cash

(with a rating of 90 pts. -94 pts.)

3<sup>rd</sup> Place - Five Thousand Pesos (5,000.00) cash

(with a rating of 85 pts. -89 pts.)

4<sup>th</sup> place – Four Thousand Pesos (4,000.00) cash

(with a rating of 83 pts.- 84 pts.)

5<sup>th</sup> place - Three Thousand Pesos (3,000.00) cash

(with a rating of 81 pts. - 82 pts.)

6<sup>th</sup> – 10<sup>th</sup> place – Two Thousand Pesos (2,000.00) cash consolation prize

(with a rating of 79 pts. - 80 pts.)

11th - 17th place - One Thousand Pesos (1,000.00) cash consolation prize

(with a rating of 77pts. -78 pts.)

SECTION 13. UTILIZATION OF CASH AWARDS- The cash prize awarded under this Ordinance shall be utilized solely on projects directly addressing the child welfare, protection and development.

SECTION 14. FUNDING – The Barangay Linao Council shall appropriate an annual budget for the purposes of the successful and efficient implementation of the Most Child-Friendly Purok Awards. The said amount shall be included in the BCPC of at least one percent from the Internal Revenue Allotment (IRA) under the Special Purpose Appropriation (SPA) of the current year.

SECTION 15. SEPARABILITY CLAUSE. Any provision or portion of this Ordinance found to be unconstitutional or invalid shall not impair the other provisions or parts thereof which shall continue to be in full force and effect.

SECTION 16. REPEALING CLAUSE- Any or all ordinances, rules, and regulations which are not inconsistent or in conflict with the provision of this Ordinance are hereby repealed and modified accordingly.

**SECTION 17. EFFECTIVITY-** This Ordinance shall take effect immediately in compliance with the provision of Section 59 of RA 71 60, otherwise known as the Local Government Code of 1991.
