**AN OMNIBUS RESOLUTION APPROVING THE TWO (2)
SEPARATE APPLICATIONS FOR ACCREDITATION
WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF
THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS,
TO WIT:**

- 1. UNIFY INC.; AND**
- 2. MANLILINAO FARMERS ASSOCIATION (MAFA)**

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in this City;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty - day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of two (2) separate applications for accreditation of the aforementioned CSOs;

WHEREAS, UNIFY INC., duly registered with the Securities and Exchange Commission on 26 January 2021, is a youth organization and a youth-serving organization envisioning a united Filipino youth whose primary goal is to fill gaps of the government services program. Its mission is to tap the skills of the youth to create impact-based projects, programs and activities, thereby empowering them to be productive youth not just in nation-building, but in the nation running;

WHEREAS, MAFA, duly registered with the Department of Labor and Employment on 23 March 2015, is an organization of farmers which seeks to develop a sustainable livelihood through the conduct of activities, like maintaining egg layering, planting of sweet potato, corn, peanut, ginger and turmeric, with the aim of uplifting the economic condition of the members;

WHEREAS, this Sanggunian, after thorough review of the aforementioned applications for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the City Government in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the applications to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Roiland H. Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Gregorio G. Yrastorza III, Peter M. Rodriguez, Lalaine A. Marcos and Joan Marbie C. Simbajon; be it




