A RESOLUTION FURTHER AMENDING **ANNEXES** "A" AND "R" OF SANGGUNIANG PANLUNGSOD NG ORMOC RESOLUTION NO. 2019-001, 'A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15TH SANGGUNIANG PANLUNGSOD ORMOC" NG AS **AMENDED** RESOLUTION NO. 2022-018 AND RESOLUTION NO. 2020-013, RESPECTIVELY

WHEREAS, this Sanggunian passed a Resolution No. 2019-001, entitled: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15TH SANGGUNIANG PANLUNGSOD NG ORMOC" which specifically provided for, among others, the establishment and creation of the Twenty-five (25) Committees of the 15th Sangguniang Panlungsod, the composition of each standing committee is reflected in Annex "B" of said Internal Rules;

WHEREAS, on July 30, 2019, this Sanggunian passed Resolution No. 2019-016 amending among others, Annex "B" of the approved Internal Rules of the 15th Sanggunian and provides for the new composition of certain standing Committees in order to render effective public service and governance to the constituents of the City of Ormoc;

WHEREAS, on January 14, 2020, this Sanggunian passed Resolution No. 2020-013 further amending and reorganizing the compositions of the Committee on Environment, Natural Resources and Energy Conservation and Committee on Trade, Commerce & Industry for purposes of efficient supervision and administration of the City of Ormoc;

WHEREAS, on January 25, 2022, this Sangugnian passed a Resolution No. 2022-018, entitled: "A RESOLUTION AMENDING ANNEX "A" OF THE INTERNAL RULES OF PROCEDURE OF THE 15^{TH} SANGGUNINAG PANLUNGSOD, AS AMENDED, TO RESHUFFLE THE SANGUNIAN DISTRICTS UNDER THEIR RESPECTIVE CHAIRMANSHIPS";

WHEREAS, former SP Member Atty. Benjamin S. Pongos, Jr. had tendered his resignation and the same was accepted by the 15th Sanggunian on March 5, 2022 per SP Resolution No. 2022-063 thereby causing a vacancy on the Sanggunian Chairmanship, Vice Chairmanship and Membership of the standing Committees, as well as in the Barangay assignments;

WHEREAS, considering the vacancy due to resignation of former SP Member Atty. Benjamin S. Pongos, Jr., it is deemed proper that the Chairmanship, Vice Chairmanship and Membership of the standing Committees, as well as the Barangay assignments, be reconstituted;

WHEREAS, a copy of the amended Annexes "A" and "B" containing the new assignments of the Barangays, and Committees of the respective chairmanships of this Sanggunian, are hereto attached and made an integral part of this resolution;

WHEREAS, the Internal Rules of Procedure adopted by this Sanggunian lays down the basis and procedure for its authority and power to fill up vacancies as well as to reorganize chairmanship, vice-chairmanship and membership in its regular committees, and to reassign the Barangays, under the chairmanship and assignment of the former SP Member Benjamin S. Pongos, Jr., thru a resolution specifically passed for such purpose;

Marcos, Esteban V. Laurente, Peter M. Rodriguez and Joan Marbie C. Simbajon; be it
