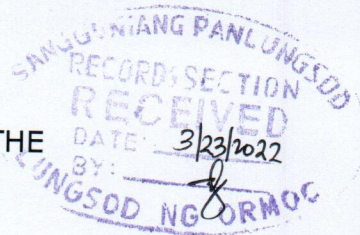

**A RESOLUTION APPROVING AND AUTHORIZING THE
PURCHASE OF TWO (2) UNITS BRAND NEW SERVICE
VEHICLES OF THE ENVIRONMENT AND NATURAL
RESOURCES OFFICE (ENRO)**

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated March 21, 2022 respectfully requesting for passage of a resolution granting authority to purchase Two (2) Units Brand New Service Vehicles of ENRO, to wit:

(1) Canter Field Vehicle	Php 2,791,608.00
(1) All Terrain Built Up Vehicle	2,559,250.00

WHEREAS, the requested vehicles shall be for the efficient execution of business operations and/or transactions of the aforementioned office;

WHEREAS, the City Accountant and the City Budget Officer issued a Certificate of Availability of Funds dated March 17, 2022 stating therein that the amounts for the aforesaid purchases is deemed available and are sourced from the CY 2022 General Fund, a copy of the certification is hereto attached as Annex "A" and made integral part hereof;

WHEREAS, to recall, this Sanggunian approved Appropriation Ordinance No. 2022-001 otherwise known as the 2022 Annual Budget of the City of Ormoc enacted on December 14, 2021, approving therein a total budget of Thirty-One Million Six Hundred Thousand Philippine Pesos (Php31,600,000.00) under the General Fund intended for Motor Vehicles purchases;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;



ADOPTED, March 22, 2022.


