A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) TO BE INTO BY AND BETWEEN ENTERED THE CITY GOVERNMENT OF ORMOC AND THE OFFICE OF THE PRESIDENT, FOR THE RELEASE OF FUNDS BY THE LATTER TO THE CITY OF ORMOC IN THE AMOUNT OF TWENTY MILLION PHILIPPINE **PESOS** (PHP20,000,000.00) TO BE USED **FOR** THE DEVELOPMENT OF BARANGAY DOLORES HOUSING

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated March 22, 2022 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or Acting City Mayor the authority to sign the Memorandum of Agreement (MOA) to be entered into by and between the City Government of Ormoc and the Office of the President, for the release of funds by the latter to the City of Ormoc in the amount of Twenty Million Philippine Pesos (PHP20,000,000.00) to be used for the development of Barangay Dolores Housing. Further requesting that this matter be treated as EXTREMELY URGENT, a copy of the MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Annotation dated March 22, 2022, the City Legal Office finds nothing legally objectionable in the said MOA and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interests of Ormoc City;

WHEREAS, in a Letter dated March 21, 2022, City Mayor Richard I. Gomez respectfully wrote to President Rodrigo R. Duterte to fund the concreting of access roads of NHA Dolores in the amount of Twenty Million Philippine Pesos (Php20,000,000.00), a copy of the Letter is hereto attached as ANNEX "B" and made an integral part hereof;

WHEREAS, Article I, Section 25 (c) of LGC provides that "The President may, upon request of the local government unit concerned, direct the appropriate national agency to provide financial, technical, or other forms of assistance to the local government unit. Such assistance shall be extended at no extra cost to the local government unit concerned";

WHEREAS, Section 17 (f) of the same states that "The national government or the next higher level of local government unit may provide or augment the basic services and facilities assigned to a lower level of local government unit when such services or facilities are not made available or, if made available, are inadequate to meet the requirements of its inhabitants";

WHEREAS, the City, on its part, is required to return the grant not utilized or remaining after the project's completion and to submit reports of the progress of the projects or its completion;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, finds that the same is entered into for the best interests of the City and its constituents;

Greetings!

On July 6, 2017, Ormoc was struck by a magnitude 6.5 earthquake which left hundreds of families homeless. In response, the National Housing Authority built houses for these families and provided for a permanent housing program designed to provide suitable and acceptable housing for qualified informal settler families most of whom are, if not unemployed, come from the informal sector. One of the two NF(A resettlements in the City is located at Barangay Dolores where the houses of which have been completed but the access road towards the area and within its premises have yet to be concreted.

Given its sizeable area with a total of 17,037.20 sq. m, the concreting of these roads will need substantial funding. It is this light that the Local Government Unit of Ormoc seeks the assistance of your good office in securing the needed funds to finance the project. The city hopes to be able to source the sum of TWENTY MILLION PESOS (Php 20,000.000.00) for the development of roads at the Barangay Dolores housing with your assistance and through the auspices of your office. I hope you can help us in our mandate to provide basic services and facilities which includes roads. I undertake to submit all pertinent attachments under DBM Local Budget Circular No. 142 and/or other pertinent issuances.
