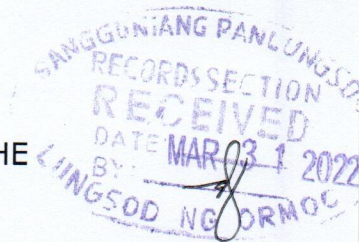

**RESOLUTION NO. 2022-090**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY  
MAYOR RICHARD I. GOMEZ OR THE ACTING CITY  
MAYOR TO ENTER INTO AND SIGN THE DEED OF  
DONATION (DOD) TO BE MADE AND EXECUTED BY  
AND BETWEEN PITMASTER FOUNDATION, INC.,  
HEREIN REFERRED TO AS DONOR, AND THE CITY  
GOVERNMENT OF ORMOC, HEREIN REFERRED TO AS  
DONEE, FOR ONE (1) UNIT OF AMBULANCE WITH  
MEDICAL SUPPLIES AND ACCESSORIES**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated March 28, 2022 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor or Acting City Mayor to enter into and sign the Deed of Donation (DOD) to be made and executed by and between Pitmaster Foundation, Inc., herein referred to as Donor, and the City Government of Ormoc, herein referred to as Donee, for one (1) unit of ambulance with medical supplies and accessories. Further requesting that this matter be treated as EXTREMELY URGENT, a copy of the DOD is hereto attached as Annex "A";

WHEREAS, in an Annotation dated March 28, 2022, the City Legal Office finds nothing legally objectionable in the said DOD and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;

WHEREAS, the Donor, Pitmaster Foundation Inc., is a non-stock, non-profit corporation, providing aid to indigent Filipinos nationwide with timely-medical assistance and emergency relief;



WHEREAS, due to the generosity and appreciation of the Donor, and in support to the national and local government's health programs, they wish to donate one (1) unit of Land Ambulance with medical supplies and accessories to the Donee;

WHEREAS, the City of Government of Ormoc is in need of additional ambulance;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned Deed of Donation, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation, among other lawful purposes, improves the emergency response of the City, deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on joint motion of SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Health & Sanitation and SP Member Nolito M. Quilang, Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Roiland H. Villasencio, Jasper M. Lucero, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE DEED OF DONATION (DOD) TO BE MADE AND EXECUTED BY AND BETWEEN PITMASTER FOUNDATION, INC., HEREIN REFERRED TO AS DONOR, AND THE CITY GOVERNMENT OF ORMOC, HEREIN REFERRED TO AS DONEE, FOR ONE (1) UNIT OF AMBULANCE WITH MEDICAL SUPPLIES AND ACCESSORIES;



RESOLVED, FURTHER, that a copy of the final notarized Deed of Donation be submitted to this Sanggunian for its information and files;


