**RESOLUTION NO. 2022-098**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY  
MAYOR RICHARD I. GOMEZ, OR ACTING CITY MAYOR,  
OR HIS REPRESENTATIVE, TO GIVE OUT ASSISTANCE  
TO AREAS IN LEYTE AND SOUTHERN LEYTE THAT ARE  
HIT BY TYPHOON AGATON, SUBJECT TO THE  
FOLLOWING CONDITIONS:**

- (A) DECLARATION OF A STATE OF CALAMITY IN THE  
AFFECTED AREAS WHEN REQUIRED BY  
PERTINENT RULES;**
- (B) TURN OVER TO, ADMINISTRATION &  
DISBURSEMENT OF THE ASSISTANCE TO THE  
PHILIPPINE NATIONAL RED CROSS (PNRC) AS  
REQUIRED BY COMELEC RESOLUTION NO. 10747,  
WHEN APPLICABLE;**
- (C) OBSERVANCE OF COA RULES & REGULATIONS.**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated April 12, 2022 from the Office of the City Mayor requesting for issuance of a Resolution granting the City Mayor to give out assistance to areas in Leyte and Southern Leyte that are hit by typhoon Agaton, subject to the following conditions:



- (a) declaration of a state of calamity in the affected areas when required by pertinent rules;
- (b) turn over to, administration & disbursement of the assistance to the Philippine National Red Cross (PNRC) as required by COMELEC Resolution No. 10747, when applicable;
- (c) Observance of COA rules & regulations.

A copy of the Indorsement is hereto attached and is made an integral part hereof. Further requesting that this matter be treated as EXTREMELY URGENT;

WHEREAS, April 11, 2022, Typhoon Agaton (international code name: Megi) caused widespread devastation and massive damage to houses, infrastructure, properties, and agriculture, and resulted in the disruption of critical lifelines of Filipinos in areas affected by the said typhoon;

WHEREAS, likewise having gone through a number of similar catastrophes, the people of Ormoc profoundly commiserates with its fellow neighbors of the Island of Leyte;

WHEREAS, the City Disaster Risk Reduction and Management Council in Resolution No. 5 dated April 12, 2022 has recommended the release of funds and assistance to the affected areas or those which have declared under state of calamity.

WHEREAS, the City of Ormoc has also been a recipient of various assistance from generous donors during the time when it was also in dire situations and as a way of paying it forward, manifested its desire to extend financial assistance to these severely affected LGUs;

WHEREAS, the electoral campaign period for the 2022 Local Elections is from March 25, 2022 to May 08, 2022 carrying with it certain electoral prohibitions in accordance with the Omnibus Election Code of the Philippines and Comelec Resolution No. 10747 dated December 16, 2021;

WHEREFORE, on MASS MOTION of the Body; be it

RESOLVED, AS IT HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR RICHARD I. GOMEZ, OR ACTING CITY MAYOR, OR HIS REPRESENTATIVE, TO GIVE OUT ASSISTANCE TO AREAS IN LEYTE AND SOUTHERN LEYTE THAT ARE HIT BY TYPHOON AGATON, SUBJECT TO THE FOLLOWING CONDITIONS:

- (A) DECLARATION OF A STATE OF CALAMITY IN THE AFFECTED AREAS WHEN REQUIRED BY PERTINENT RULES;
- (B) TURN OVER TO, ADMINISTRATION & DISBURSEMENT OF THE ASSISTANCE TO THE PHILIPPINE NATIONAL RED CROSS (PNRC) AS REQUIRED BY COMELEC RESOLUTION NO. 10747, WHEN APPLICABLE;
- (C) OBSERVANCE OF COA RULES & REGULATIONS.



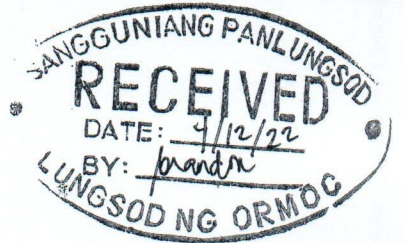

**CDRRMC RESOLUTION NO. 05**

*Series 2022*

**A RESOLUTION TO PROVIDE DISASTER RELIEF OPERATIONS AND/OR ASSISTANCE TO AREAS AFFECTED BY TROPICAL DEPRESSION "AGATON" OR THOSE WHICH HAVE BEEN PLACED UNDER A STATE OF CALAMITY**

**WHEREAS**, the impact of Tropical Depression AGATON (international name "MEGI") which traversed Eastern Visayas from April 9 to April 12, 2022 causing widespread devastation resulting to flooding and landslides incidents, population displacement, casualties, agricultural damage, and critical lifeline damages;

**WHEREAS**, Implementing Rules and Regulations of Republic Act 10121 (Rule 18 Section1). Upon the recommendation of the LDRRMO and approval of the sanggunian concerned, the LDRRMC may transfer the said fund (LDRRMF) to support disaster risk reduction work of other LDRRMCs which are declared under state of calamity;

**WHEREAS**, the City of Ormoc has also been a recipient of various assistance from generous donors during the time when it was also in dire situations and as a way of paying it forward;


**NOW THEREFORE**, on motion of CDRRM Council member, Engr. Raoul Cam of City Planning and Development Office and duly seconded by Engr. Domardoni C. Cayanong of City General Services Office, Be it;

**EXECUTIVE ORDER NO. 139**  
11 April 2022

**DECLARING A STATE OF CALAMITY IN BAYBAY CITY, LEYTE  
DUE TO TROPICAL STORM AGATON**

**WHEREAS**, since 10 April 2022 up to the present, torrential rains from Tropical Storm "Agaton" caused landslides and flooding in different barangays of Baybay City, Leyte, resulting in loss of life, injuries to numerous individuals, widespread damage to houses and infrastructures, and the overall disruption of the lifelines of people in the city,

**WHEREAS**, the declaration of a state of calamity in the entire City of Baybay, Leyte, will hasten the rescue, relief, and rehabilitation efforts of the government and the private sector, including humanitarian assistance from different local government units, agencies of the government and other entities,

**WHEREAS**, the declaration of a state of calamity will, among others, effectively control the prices of basic goods and commodities in the city, and afford the city government ample latitude to utilize appropriate funds for the rescue, recovery, relief and rehabilitation of, and the continuation of basic services to, affected populations, in accordance with law,

**WHEREAS**, pursuant to the authority of the Local Chief Executive to exercise powers, and perform such duties and functions which are essential for the maintenance of peace and order, and to preserve the comfort and convenience of the inhabitants of Baybay City, Leyte, and as Chairman of the Local Disaster Risk Reduction and Management Council (LDRMC), it is deemed necessary that a declaration of a state of calamity in the City of Baybay be made for the safety and welfare of everyone;

**NOW THEREFORE, I, JOSE CARLOS L. CARI**, by virtue of the powers vested in me by law, do hereby declare a State of Calamity in the City of Baybay City, Leyte due to Tropical Storm Agaton.

All departments of the city government, and other concerned government agencies are hereby directed to implement and execute rescue, recovery, relief, and rehabilitation work in accordance with pertinent operational plans and directives. All departments of the city government and other concerned agencies are also hereby directed to coordinate with, and provide or augment the basic services and facilities of the affected barangays.

Law enforcement agencies, with the support from the Armed Forces of the Philippines, are hereby directed to undertake all necessary measures to ensure peace and order in the city.

The State of Calamity shall remain in force and effect for a period of one (1) month unless sooner lifted or extended in accordance with law.

This executive order shall take effect immediately.
